## IHA Dressage Year End Awards

1. The rider must be a member of the Islip Horsemen's Association prior to the first class of the first show in which the scores are to count; and, must ride in two of three shows.
2. To qualify for year end awards, a horse and rider must have four or more scores from two different judges within the level during the series. At least one of those scores must be from test 3 or C. The four highest scores from at least two different judges, including at least one test 3 or C score, whether or not it is one of the highest, will be averaged. All horses and riders must obtain a median average score of at least 50% to qualify in any/all divisions.
3. All conflicts will be settled by the binding decision of the IHA Committee. The Committee, under the direction of the Executive Board of the IHA reserves the right to revise these requirements as warranted in the event of an alteration to the show schedule. In addition, the Committee reserves the right to examine original tests and results at their discretion. Any dispute not covered by the rules and regulations will be submitted to the committee for further review and their decision shall be final.
4. Classes 14, 15, 16, 17 will not be eligible for year end awards.

## Western Dressage Series Year End Awards

1. Exhibitors must be members of IHA prior to the first show.
2. Rider and horse must attend two of three shows and present a minimum of four scores under two different judges.
3. Prize awarded to the junior or adult overall High Score Champion and Reserve of the Western Dressage division.

# IHA Dressage Rules and Regulations and General Information

1. Limit of 70 rides per show. The first 70 rides with a correctly completed entry form and payment received after the opening date and before the closing date will be accepted. If entries fill before the closing date, a waiting list will be formed in the order in which the entries were received. Entrants will be notified to fill any scratch times. If declined, payment will be returned to the entrant.
2. A horse is limited to three (3) tests per show. NO EXCEPTIONS.
3. All classes being offered herein will be conducted and run in accordance with the Islip Horsemen's Association Rules & Regulations as well as the current USDF/USEF rules, unless otherwise specified. IHA, USDF & USEF rules go into effect upon arrival to the show grounds.
4. Management reserves the right to cancel, combine or divide any classes. At the discretion of the show committee, all classes may be split into Adult & Junior if there are three (3) or more entries in each class. Committee reserves the right to combine or cancel any class with less than three (3) entries.
5. No refund of entry fees after the closing date shall be made unless in the case of waiting list entries, class is cancelled, or in the case of a horse or rider's inability to perform. Veterinarian or doctor's note required within ten (10) days of the show in which entries are to be refunded. A \$25.00 handling fee will be assessed for any returned checks.
6. Tentative times will be available on the IHAD FB page, the IHA website at [www.isliphorsemensassociation.com](http://www.isliphorsemensassociation.com) or by email.
7. All participants, riders and spectators on premises are there at their own risk. Islip Horsemen's Association, County of Suffolk, Department of Parks and the Show Committee disclaim any liability for any accident or occurrence regardless of the cause.
8. Any horse brought to the show grounds for schooling purposes must register upon arrival and pay a fee of \$20.00, Suffolk County fee and number fee. Schooling horses will receive a number and must have their number visible at all times while being ridden or lunged on show grounds.
9. For insurance purposes: all riders are required to wear protective head gear at all times when mounted. No dogs are permitted on the show grounds, with the exception of service dogs.
10. Footing is standard sand arena. Schooling on sand.
11. Proper attire is required. Jackets may only be waived at the judge's discretion.

12. For Dressage, prizes and six ribbons in each class. Champion & Reserve Champion ribbons will be awarded for High Score and Reserve High Score at each level. High Score End of Day and Reserve Championship ribbons are awarded to the High Score Junior & the High Score Adult of each show.

13. For Western Dressage, prizes and six ribbons in each class. Champion & Reserve Champion ribbons will be awarded for High Score and Reserve High Score at each level. High Score End of Day and Reserve Championship ribbons are awarded to the high score Junior & the High Score adult of each show.

14. All riders, youth and adult, must wear properly fitting equestrian helmet, passing or surpassing current applicable ASTM/SEI standards, with chin strap secured, while mounted at any time, anywhere on the competition show grounds.

The Islip Horsemen's Association and officials make no representation or warranty, express or implied, about any protective equestrian helmets and cautions riders that death or serious injury may result despite wearing such equestrian helmet as all equestrian sports involve inherent dangerous risk and as no helmet can protect against all foreseeable injuries.

## Unsportsmanlike Conduct

- No exhibitor will visit or socialize with a judge the day of the show. Furthermore, exhibitors shall not approach judges for any reason prior to or after the completion of judging unless a request is made to show management and with the ring steward or other show official present.
- Conduct by judges, IHA members and non-members, volunteers, exhibitors, trainers, owners and their representatives, spectators and all other persons present on the show grounds or in show facilities shall be orderly, responsible, sportsmanlike, courteous and respectful. Direct abusive and threatening conduct while on the show grounds will not be tolerated and the offending persons(s) may be asked to leave the show grounds in order to preserve the decorum of the show.
- A violation of either of these rules will first result in a written warning from the show committee to the party(ies) involved in the initial violations, which shall also be forwarded to the IHA Board, within five (5) days of the incident; a second violation of these rules will be brought to the IHA Board for review and any action will be left up to their discretion, which may include but not limited to, removal of points earned on the date of the incident, disciplinary action and/or suspension from IHA club activities for a period of time to be determined by the IHA Board.

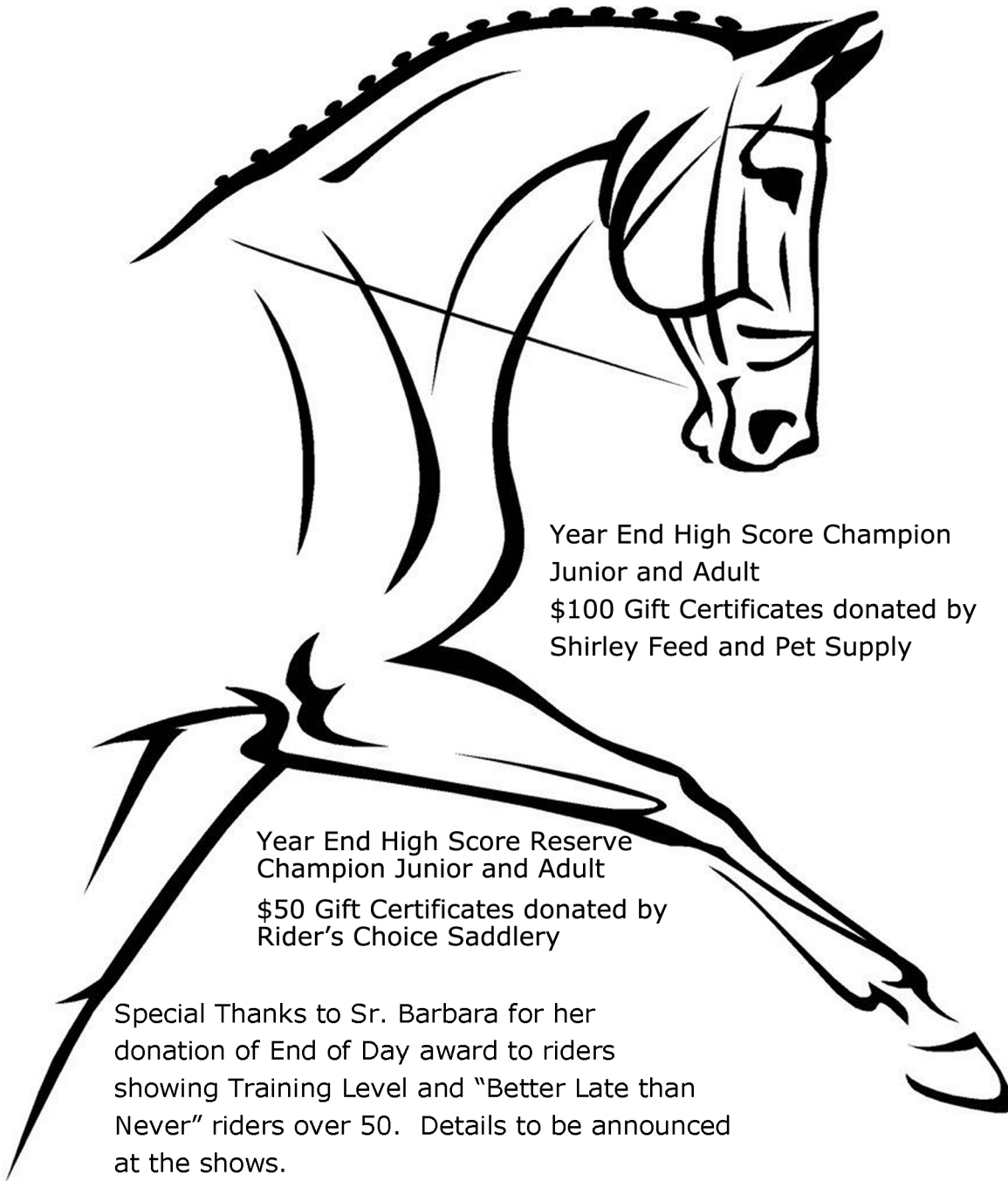

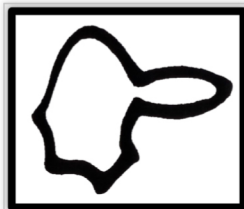
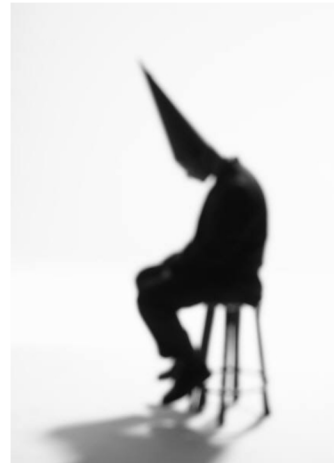
