#### **Schedule**

Grounds will be available one hour prior to trial hours. Trial hours are 9:00AM until 3:00PM or until all runs are completed. It is also the responsibility of each entrant to try to be ready with catcher and releaser when their dog is called to the line.

#### Roll Call

You may check in at 8:30 am for inspection prior to the beginning of the trial, or throughout the event. Every dog must pass through roll call inspection before running. Dogs who miss roll call will be skipped. If you do not check in within one hour prior to the end of the trial closing, we will assume you are absent, and you will lose your turn. No refunds for absent dogs. At roll call, all dogs will be examined for disqualifications. Bitches known to be in season are not to be brought to the test. At inspection, bitches in season, lame and unfit dogs will be excused with entry refunded.

#### **Prizes**

A flat blue ribbon for a passing qualifying run.

Rosettes to dogs completing titles BCAT, DCAT or FCAT, as available (at least one will be available for a picture and we will mail a rosette if we run out).

Please notify the Trial Secretary in advance if you anticipate completing a title.

Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program on the day of the trial. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

Dogs may only run once per test. All entries must be accompanied with a check to be valid. A returned check is not a valid entry.

#### What is the Fast CAT?

- 1. Fast CAT is a timed straight 100-yard dash for dogs.
- 2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.
- 3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).
- 4. Based on the dog's size at the withers a handicap is applied and points are earned:
  - 18" or greater = Handicap is 1.0
  - 12" up to less than 18" = Handicap is 1.5.
  - Under 12" = Handicap is 2.0.

#### 5. FORMULA: MPH X HANDICAP = POINTS

6. Titles are earned at specific point levels

BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points

FCAT# = Each additional 500 points

\*ACCORDING TO AKC RULES; Handlers are not permitted to run with a dog during an official run but must remain either at the start or finish area of the course. Handlers are not to allow dogs to be enticed through the course with anything other than the lure during its official run. NO mechanically devices including whistles, horns, bull horns, etc. or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.

#### **Trial Information**

- Dogs should be warmed up before and cooled down after running.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- All entries must be 12 months of age or older on the day of the test.
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water. Shade tents, crates, etc. my be left over night at owner's risk.
- Kiddie pools will be available for use during the event
- An electric and electronic timing system will be used.
- The show grounds are not completely fenced. The FAST CAT course will marked off with snow fencing.
- On-site porta-pottys with hand washing stations are available.
- Dogs must be on lead or crated unless running.
- A fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- Any dog that eliminates on course or in the run-out area will receive a nonqualifying (NQ) score.
- Muzzles are allowed. No pinch collars, and no electronic training collars or devices are allowed. The club recommends using a plain buckle collar and lead. No flexi leads will be allowed for safety reasons.
- Each dog requires an individual entry form for each event in which it is entered.
- Bitches in season and lame dogs will be excused. Entry fees will be refunded only if they show up to the event and are excused.
- The Hunt master is responsible for field safety and therefore he/she is in complete charge
  of all dogs and handlers on the field. He/She has the authority to stop the lure in any
  potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the AKC/CCDAC/DDOM/ dog(s) or person(s) will be asked to leave the trial site by the Field Committee, maybe disciplined by the AKC, and entry fees will not be refunded.
- No entry fees will be refunded if the event cannot be started or completed by reason of
  riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God,
  public emergency, act of a public enemy, strikes or any other cause beyond the control
  of the Club.
- The event-hosting club, Canine Combustion Club of SE Michigan, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

In using any, some or all of the Facilities for any one of more of the Events, I recognize and fully understand certain things, including:

- (a) there will be no lifeguard or other safety monitor, guard, rescue personnel, or protector on duty for any of the Facilities;
- (b) my use and my pet's use of the Facilities during Events involves certain risks, including but not limited to: the risk of injury resulting from possible malfunction of the equipment and structures at the Facilities; the risk of injuries resulting from tripping or falling over obstacles at the Facilities; the risk of injuries resulting from unsupervised pool users colliding; the risk of other injuries resulting from participating in the Events and using the Facilities.

I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risks; the list only provides examples of types of risks that I am assuming for my pets and me.
