For the purposes of this agreement, "Party" will refer to member or non-member sponser renting property for a party; and "Pool" will refer to pool manager or board member.

PLEASE INITIAL EACH OF THE FOLLOWING:

- _____ Deposit of 50% required to reserve date;
- _____ All parties must be paid in full one week before the party date;
- _____ Party will observe and obey all pool rules posted; Party will observe and obey all rules given by Pool and Lifeguards;
- _____ Set up time is 30 minutes prior to the party time. Party should not attempt to gain access to the party area prior to this time;
- _____ Clean up time shall last 15 minutes after the reserved party time;
- _____ Party will be charged an additional \$25 per quarter hour that it stays on property past reservation;
- _____ Party may not move furniture without approval of "Pool";
- _____ Swimming attire must meet the standards of decency for a neighborhood-family pool. Cut-off jeans are not acceptable;
- _____ Only diapers certified by the manufacturer designed for swimming pool use will be allowed in pool;
- _____ No persons under the age of 12 are permitted on the second story sun deck unless accompanied by their parent;
- _____ The party host and guests agree to leave the premises in as good or better condition than which existed prior to their usage.
- _____ Refunds are as follows: full refund for weather, full refund if cancelled 7 days before and 50% refund if party is cancelled less than 7 days before date.

FOR OPEN-HOUR PARTIES ONLY:

- _____ Reserved tables for parties are in the grassy area of the property;
- _____ Party may not take/use any of the tables or lounge chairs around the pool or baby pool area during the party;
- _____ Pool will assign 25 wristbands, which must be worn during the party, by both members and guests;
- _____ A \$25 per person fee will apply for each additional guest beyond 25

Being a member non-member of the West Coronado Community Recreation Association (WCCRA), an organization commonly known as the Bel Mar Pool, contracting to use the pool facilities for a party, I, for myself and spouse, my children, heirs, personal representatives, successors, and assigns, agree to release, waive, indemnify and defend WCCRA and the Bel Mar Pool and its board members, officers, volunteers and employees, and their respective heirs, personal representatives, successors, and assigns, from and against any and all claims, causes of action, damages, injuries, liabilities, losses, suits, expenses (including costs and reasonable attorney's fees), or harm of any kind, whether existing now or in the future, whether or not foreseeable, of or brought by my spouse, any of my children, any members of my family, or any guests of any of them specifically including party guests, arising in whole or part, directly or indirectly, out of any use of or presence at WCCRA equipment or facilities or any alleged acts or omissions, whether negligently or otherwise occurring, of any such indemnified and released parties.
