

### From the Kitchen:

#### Craisen Salad

1 head romaine lettuce  
1 cup dried cherries or raisins  
1 cup cashews  
1 pear, cut up  
1 apple, cut up  
1 cup grated swiss cheese

#### Dressing:

1/2 cup freshly squeezed lemon juice  
1/3 cup olive oil  
1 tsp. poppy seeds  
1 tsp. Dijon mustard  
1 tsp. salt  
1/2 cup honey  
1/8 cup red onions

Mix dressing together and serve over the salad.
