## **GUARANTEED REGISTRATION**

Seller certifies that this puppy is of purebred quality. Breeder has made application for litter registration and individual dog papers will be issued to the buyer upon receipt. Please note, papers are processed via a third party registration company. Processing time can vary. However, papers are guaranteed.

## **HEALTH GUARANTEE**

To the best of the Sellers knowledge the puppy is free of any communicable or hereditary defects. Should the puppy be diagnosed with crippling hip Dysplasia (moderate or severe HD or ED) or any hereditary or genetic problem which is untreatable and/or life threatening prior to its second birthday, Seller agrees to refund 1/3 of the purchase price of the puppy. Buyer must give Seller proof of diagnosis then present the puppy to veterinarian of Sellers choice to confirm diagnosis. Under no circumstances will Seller pay veterinary or transportation costs. The Buyer may keep the original dog but it must be spayed or neutered and a copy of the certificate of spay or neuter must be returned to Enchanted Long Coat German Shepherds. No refund will be honored after 24 months (2 years) of age!

Please note that any form of the mange or skin disorder is an excluded liability of

the Seller.

## ADDITIONAL PROVISIONS AND TERMS OF SALE

A) Buyer agrees to provide for this dog's emotional and physical care, including annual physical examinations and recommended vaccinations by a licensed veterinarian; nutritious food, etc.

B) Seller strongly recommends that Buyer attend obedience classes with puppy and provide proper socialization opportunities for puppy. Seller shall not be held responsible for the actions of a puppy that are due to Buyer's negligence.

C) Seller recommends neutering (males) and spaying (females) at the age of 24 months. Altered dogs typically live a healthier life and generally have fewer behavioral problems.

D) Buyer agrees to inform Seller if the Buyer intends to sale or transfer ownership to a third party. FIRST OPTION to resume full ownership must be given to Seller at a price and/or with terms mutually agreed upon by both parties. This would take into consideration the costs incurred by the breeder in caring for the dog and locating a new home. The dog will be returned with the registration papers and any/all medical records. The Seller has ten (10) days to accept or reject this right of FIRST-OFFER. If this dog should, at any time in its lifetime, need to be surrendered at no cost, the Breeder/Seller will reclaim this dog, and its disposition becomes the choice of the Breeder/Seller. Under NO circumstances is the dog to be placed in a pet shop, animal shelter or similar establishment. Under NO circumstances is the dog to be used in dog fighting or similar activities.

F) Should the Buyer be unable or unwilling to fulfill any of the above provisions, or if this dog is seized by any local authority as having been neglected or abandoned, the Seller retains the right to reclaim this dog without compensation to the Buyer. The Buyer agrees to pay the Seller and all expenses, including court costs and responsible attorney fees, in enforcing the terms and provisions

of this contract. Canines are livestock and therefore cannot be returned for any reason other than those stipulated in the Health Agreement or Additional Terms and Provisions sections of this contract.

## ACCEPTANCE

The undersigned Buyer hereby acknowledges having read the terms of this contract and does hereby agree to abide by each of the provisions set forth above. Buyer acknowledges that no canines purchased through Enchanted Long Coat German Shepherds shall be used for any illegal purposes. If voluntary arrangements are made by the Seller to repossess the puppy due to the Buyer's inability to retain possession, all cost for shipping is the sole liability of the Buyer. **ALL SALES ARE FINAL.**
