- 2. OPENED REGULAR MEETING: (Chairman) Jim Rowles, opened regular meeting noted we have four Board members present.
- 3. CLERK'S REPORT: (Clerk) Jan Hamilton, began her report by stating that we were over budget in Postage, and Water testing. Jan went on to say that the two extra bond payments have been mailed to the State and the Federal. (Chairman) Jim Rowles, moved that they accept the clerks report. (Vice Chairman) James Jorgenson, seconded it. All in favor. Unanimous.
- 4. TREASURER'S REPORT: (Treasurer) Lauri Burris, began her report by stating that the General account has (\$84,307.65), the Rural Development account has (\$5,163.00), P.T.I.F. accounts have (\$240,201.06), for a grand total of (\$329,671.71). (Chairman) Jim Rowles, moved that they accept the Treasurer's Report. (Clerk) Jan Hamilton, seconded it. All in favor. Unanimous.

- 10. WATER MASTER REPORT: Wayne began his report by stating that last month we pumped 3,604,239 gallons of water and the daily average is 116,266. The water sample taken to St. George came back fine. Wayne went on to say we have put in 7 new water services this year. We also did 4 asphalt patches, three were for the new water services and one for a valve. We will read meters on August 26th and stuff envelopes on September 1st.
