**Federal Order Hearing Process Delay:** Today California Dairy Campaign joined Milk Producers Council and Western United Dairymen in a letter to United States Department of Agriculture (USDA) Secretary Sonny Perdue calling for the federal milk marketing order hearing process to move forward. The letter stated, "Since USDA released its draft recommendation in February 2017, producers lost an average of \$0.50 per hundred-weight of milk produced. According to USDA's *Regulatory Economic Impact Analysis of the Recommended California Federal Milk Marketing Order*, the all-milk price estimated change from the baseline for California would be \$0.48 per hundredweight. The numbers illustrate California dairy families' eagerness to see a final decision to consider. The letter went on to state, "While we can recognize USDA's inclination to wait for the Supreme Court decision in the *Lucia v. Securities and Exchange Commission*, before publishing a final decision on a California FMMO, it is not something we can support. Because of the aforementioned economic reasons, and the commitment that dairy producers have made to the FMMO process for more than three years now, California dairy producers cannot wait until the Supreme Court renders a decision on this matter, which ultimately may not prove relevant to the FMMO proceedings..."

Today California Dairies Inc., Dairy Farmers of America and Land O'Lakes also sent a letter to Secretary Perdue urging USDA to move forward in the FMMO hearing process.
