Dear Landowner,

You are receiving this letter because your property may be affected by a routing alternative for the proposed Dodge County Wind 345 kilovolt (kV) transmission line project. Different route alternatives are being evaluated in an environmental impact statement (EIS) that is being prepared by the Minnesota Department of Commerce (Department).

This letter provides you with information about the transmission line project, the route permitting process, and future opportunities to participate in the process. I encourage you to familiarize yourself with the project, sign up for the project mailing list, and participate in the permitting process.

Project

Dodge County Wind, LLC, proposes to construct a 170 megawatt (MW) wind farm consisting of up to 70 turbines to be located in Dodge and Steele counties. The output of the project will be sold to Minnesota Municipal Power Agency. The project also includes construction of approximately 21 to 26 miles (depending upon the route selected) of 345 kilovolt (kV) high voltage transmission line in Dodge and Olmsted counties to connect the wind farm to the transmission grid. The proposed transmission line would connect the newly constructed Dodge County Wind Substation located in Ripley Township in Dodge County to the Byron Substation, located just west of the city of Byron in Olmsted County.

DCW proposes to use single pole structures with heights of 80 to 140 feet, and spans of approximately 400 to 1200 feet between structures. For the majority of the proposed routes, DCW proposes a typical right-of-way (ROW) of 150 feet, with a narrower ROW (approximately 75 feet) for portions that are within road ROW. DCW has proposed two possible routes for the transmission line (shown in orange and blue in the attached map); several segments are common to both proposed routes.

Process

The Dodge County Wind project requires three separate approvals from the Minnesota Public Utilities Commission (Commission) – a certificate of need, a site permit for the wind farm portion of the project, and a route permit for the transmission line portion of the project. Dodge County Wind, LLC applied for these approvals in June 2018. The Commission has authorized the Department to prepare an EIS for the project.

The first step in preparing the EIS is scoping – i.e., gathering public input on the impacts and mitigation measures that should be studied in the EIS. A public meeting was held in Owatonna on October 25, 2018; a public comment period ended on November 15, 2018. Following the close of

the public comment period, the Public Utilities Commission reviewed route alternatives and determined that additional routes beyond those proposed by Dodge Center Wind, LLC in its route permit application, should be studied in the EIS. The new routes are shown would follow existing transmission lines through Dodge Center and Kasson, and are shown in red and green on the attached map. Property records indicate that you own property along one or more of the new routes.

All of the routing alternatives are described in the EIS scoping decision (see attached map). The scoping decision is available on the Department's website: <http://mn.gov/commerce/energyfacilities> and on the State of Minnesota's eDockets system: <https://www.edockets.state.mn.us/EFiling/search.jsp> (enter the year "17" and the number "306," "307," or "308").

A draft EIS is currently being prepared. The draft EIS will evaluate the potential human and environmental impacts for all of the alternatives in the scoping decision. If, during preparation of the EIS, Department staff determines that some route alternatives are either technically infeasible or imprudent due to impacts on humans or the environment, the EIS will NOT carry forward such routes into a detailed evaluation. In the event that any routes are not carried forward for full evaluation, the EIS will describe the considerations that led to that conclusion.

The draft EIS is anticipated to be issued in June 2019. Public meetings and a comment period on the draft EIS will follow, and a final EIS will be prepared in response to the comments received.


Public hearings will also be held in the project area after issuance of the draft EIS and are anticipated to occur in August 2019. An administrative law judge (ALJ) from the Minnesota Office of Administrative Hearings will preside over the hearings. After the hearings, the ALJ will submit a report with recommendations for the Commission's consideration in evaluating the project's CN, site, and route permit applications. Commission decisions on the applications are expected in slate 2019.

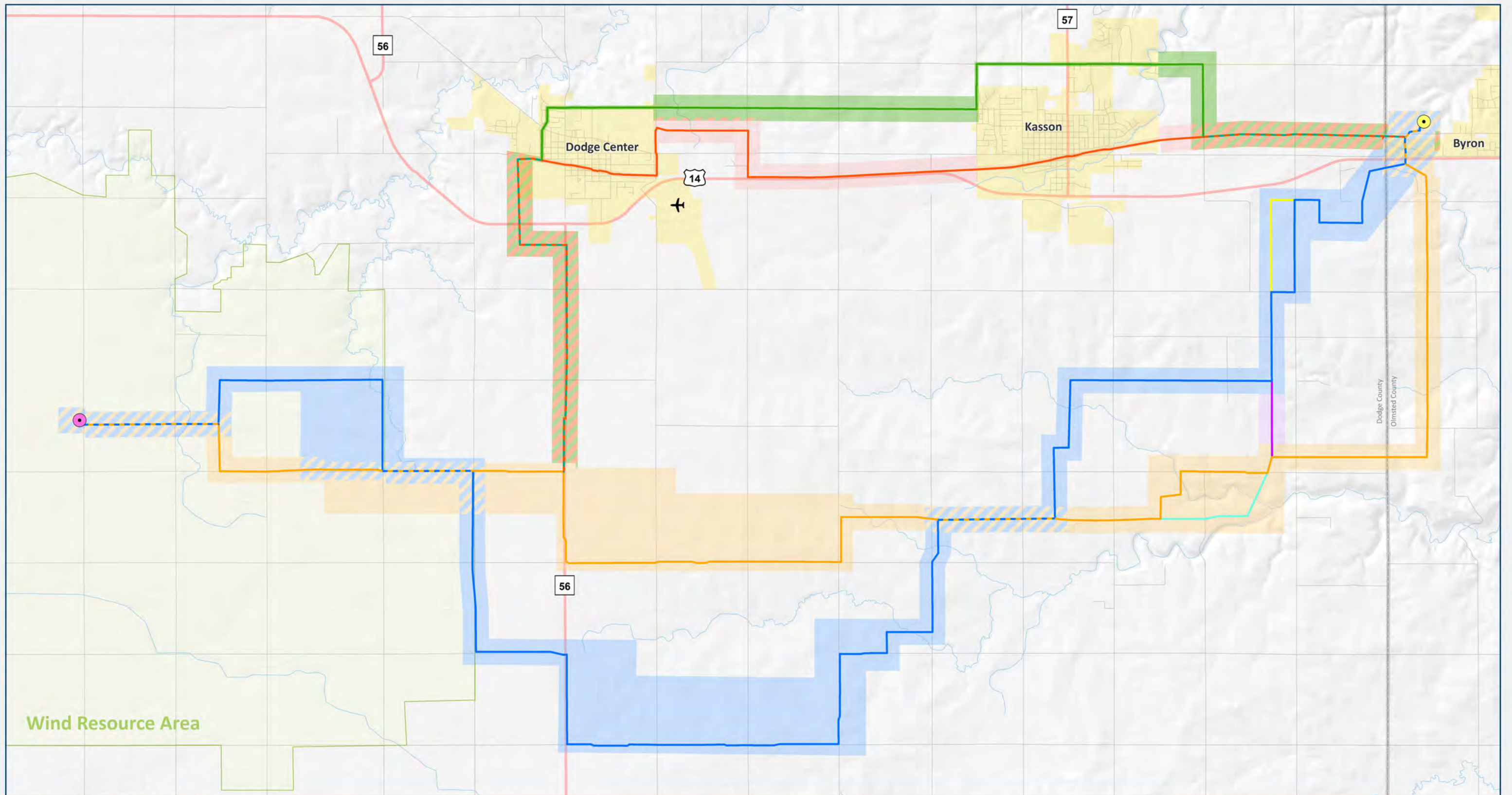

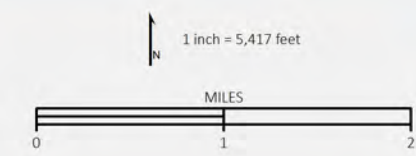


Dodge County Wind Project
