Fishing at Lake Bloomington is open to the public year round.

A cooperative effort between the Illinois Department of Natural Resources, the City of Bloomington, the Lake Bloomington Association, as well as local fishing clubs, have helped turn Lake Bloomington into one of Central Illinois' best kept fishing secrets. This ongoing fish stocking and management process provides an opportunity for anglers to test their skills on an abundance of a wide variety of game fish. Walleye, Largemouth Bass, Smallmouth Bass, Hybrid Striped Bass, Northern Pike, Crappie, Bluegill, and Catfish can all be caught in Lake Bloomington.

When fishing Lake Bloomington anglers must comply with the following rules and regulations:

- 1. Anyone 16 years of age or older must have a valid Illinois Fishing License.
- 2. 2 Pole and line fishing only. No Jugs or Trot lines.
- 3. Fish size and creel limits listed below.
- 4. Fishing from a boat around private docks is prohibited when swimmers are present and between sunset and sunrise.
- 5. No littering!

FISH SIZE	CREEL LIMITS
Large and Smallmouth Bass	Minimum 15" 6 per day
Walleye	Minimum 14" 6 per day
Northern Pike	Minimum 24" 3 per day
Hybrid Striped Bass	Minimum 17" 3 per day
White, Black or Hybrid Crappie	No Minimum Length 25 per day
Bluegill or Redear Sunfish	No Minimum Length 25 per day

EAGLES

We were all shocked, saddened and scared by the news that a bald eagle had been killed in McLean County. Dated pictures confirmed that it was not a Lake Bloomington eagle. The eagle proved to be the female from a nest near the Mackinaw River with live chicks. So far, the male eagle is still feeding the young. The Lake Bloomington eagles nested late this year, and that may have allowed them avoid the snowmobiles.

Please contact the police if you have any information about the shooting of the female eagle. And please stay away from the Lake eagles' nest. Do not approach

by water and stay on the road if viewing on land.









Boating Registration

Boating at Lake Bloomington

Recreational boating is permitted at Lake Bloomington. The boat ramp is located in Hubbard Park and can be reached by taking County Road 1750 East to Park View Lane. Turn East on Park View which will take you directly to the boat ramp and parking. Boaters must comply with the following provisions:

All boats must have a current State and City of Bloomington License.

Boat License Application

To obtain a City of Bloomington Boat License all applicants are required to show proof of watercraft liability insurance, in the amount of at least \$100,000.00, and evidence of current State Registration. License may be purchased through the mail by downloading the Application from this site and following the instructions on the bottom of the form. A copy of this application will then serve as a temporary license. A City of Bloomington License sticker will be mailed in return. City of Bloomington License are also available by using a self registration box located at the Lake Bloomington Park Office next to Davis Lodge.

Boating and Skiing Rules

Boating at Lake Bloomington

- Boats operating on the Lake must carry all State required equipment -- all boats operating in the area open Personal Flotation Devices for each passenger, a fire extinguisher, whistle or horn, etc. -- and obey all State of Illinois regulations.
- Maximum 40 horsepower limit.
- Maximum speed of 25 mph.
- All boats must obey all posted **NO WAKE** areas. The entire lake is **NO** WAKE from 1/2 hour after sunset until 7 am. A wake is defined as movement of water created by a boat underway that is great enough to disturb a boat at rest. More simply put, if you are moving fast enough that the wave coming from your boat makes another boat in the area INFLUENCE OF ALCOHOL OR OTHER bounce or move, you are going to fast and are violating the **NO WAKE** area. At no time can your speed in a **NO WAKE** area exceed 5 mph. Please be aware of the **NO WAKE** areas and do not speed through

them.

- Racing is prohibited.
- During skiing hours (noon 7pm), to skiing shall operate in a counter clockwise pattern and shall make all turns counter clockwise. See skiing below.
- All motorized boats must yield to any sail-powered or musclepowered craft.
- •All passengers must be properly seated when underway. No one should be outside of the gated area of the boat or standing.
- •All passengers under age 13 must wear approved Personal Flotation Device while the boat is underway.
- Operating a boat while UNDER THE DRUGS IS PROHIBITED.
- Careless or reckless operation of any type will not be tolerated.
- •No jet skis, jet-propelled, or air driven craft of any type are allowed.
- Swimming from boats is prohibited.

Skiing at Lake Bloomington (Including tubing or related activity)

- •Skiing is allowed from noon to 7 pm only.
- •Skiers must wear approved jacket type Personal Flotation Device.
- •At least two people qualified to operate the boat must be aboard while pulling a skier. On to act as an observer.
- Skiing within 100 feet of any dock, shore, raft, buoy, or other watercraft is prohibited.
- •Boats may pull only one person at a time.
- Skiers must start from the water, not from the shore or docks.
- Only the person actually skiing or preparing to ski shall be in the water at any time.



Lake Run Saturday May 2nd


The first Lake Run, a loop around Lake Bloomington, was held in 1982 and had 224 finishers. The race became an annual event, added a shorter loop and continues to grow each year (1,100 participants in 2012). 2014 marked the 33nd anniversary of this local favorite running event. In addition to the standard age group classifications, the race has **footpounder classes** for men over 220 lb and women over 190 lb, as well as footpounder light: 190-219 lb (men) and 150lb – 179lb (women).

In 2014 the Lake Run added an 1/2 Marathon distance to the race line up. The 1/2 marathon course will feature the best of both inner (4.37 mile) and outer loop (7.44-12K) courses. All races have chip timing and race results posted within hours of the completion of the event. Great post food, beer tent with more than one beer option and awards ceremony. Race day registration starts at 7:00am to 8:15 AM. Race start time is 8:30am for the 1/2 marathon and 12k. 9:00 am start for the 3 mile walk and 4.37 mile run.

Lake Bloomington and Lake Evergreen Watershed Social Assessment

The Mclean County Soil and Water Conservation District, in collaboration with Illinois State University, has received funding from the Illinois Environmental Protection Agency (IL-EPA) to conduct a watershed social assessment, with an emphasis on the Lake Bloomington and Lake Evergreen Watersheds. The United States Environmental Protection Agency (EPA) has acknowledged that non-point source (NPS) pollution is the leading source of water quality degradation. One significant source of NPS pollution in urban and suburban areas is fertilizer and pesticide runoff from turf grass lawns, which has been associated with a variety of water quality concerns such as algal blooms and contaminated groundwater. Other practices such as the use of water-intensive and fertilizer-hungry non-native landscaping, removal of buffer strips around waterways, excessive use of impermeable pavements, and failing septic systems can increase pollutants that enter the groundwater and contribute to NPS pollution. Locally, Lakes Bloomington and Evergreen provide source water for over 80,000 residential customers and recreation opportunities for a growing population, yet this residential population has been largely absent from outreach or educational activities in relationship to the current watershed management plans and efforts to reduce NPS pollution. As the urban population continues to grow, NPS pollution from lawn care practices and increasing use of impermeable surfaces will only rise in concern. Securing safe and adequate water resources for the future is also going to demand greater attention and planning. In light of these concerns, the assessment has identified five primary goals:

Evaluate urban resident's general level of knowledge and concerns of water quality and the effects of their activities on water quality and the practices they currently use that effect water quality (BMPs).

Evaluate onsite waste system knowledge and practice (ie: septic systems).

Evaluate knowledge of and opinions of water conservation activities on water quality and quantity.

Provide critical data to direct future outreach and education efforts.

Provide vital social data to inform an update of the current watershed management plans to more directly address social aspects of watershed management for the future.

To achieve these goals, a random sample of 1,000 residential households from within the watershed will be selected to complete a household survey during spring 2015. Households that are within the watershed or receive their source water from Lake Bloomington and Lake Evergreen will be the targeted population. This includes residential households in the Village of Hudson, the Village of Towanda, north Normal and the City of Bloomington. The survey will be administered in person during the last three weeks in May 2015 by Illinois State University students. An on-line version will also be available for anyone who was not selected at random but still wishes to participate.
