You are required to have a valid Nevada State Business License or exemption letter, Nevada Seller's Certificate or exemption letter, and Liability Insurance. If you are selling food, you are required to have all of our health department permits and food handler cards.

If you do not currently have liability insurance for your company, you may apply for Vendor Insurance with Larry Spilker at Campbell Risk Management, (317) 848-9075 ext. 203 or at www.campbellrisk.com. Insurance rates start at \$250 annually. You can also try www.fdean.com/vendors.aspx where you can apply online 24/7 and receive your certificates almost immediately.
