The regular meeting of the Board of Directors of Arrowbear Park County Water District was held January 16, 2020, at the District office, 2365 Fir Drive, Arrowbear Lake, California.

Open Session

President Bunyea called the meeting to order. Director Wymer led the recitation of the Pledge of Allegiance. President Bunyea certified the posting of the agenda. President Bunyea performed a roll call, Directors that were present: Wymer, Weber, Oberlies, Bonito, and Bunyea. Directors that were absent: None.

Approval of Consent Agenda:

Director Bonito made a motion to accept the consent agenda, second was by Director Wymer. After a brief discussion regarding the expenses and budget for the month of November and December, the consent agenda was approved. Motion passed by unanimous vote.

Public Comments:

Wayne Clemons commented on his perceptions of the fire department. President Bunyea requested Mr. Clemons supply the Board with a list of the items so that this may be placed on the Agenda for February.

Staff Reports:

A) Supervisor Miller reported a total of 16 maintenance issues for the month of November and 13 maintenance issues for the month of December. In November, there were 8 customer requests to turn off/on water, 1 District initiated shut-off, 1 District equipment

repairs, 0 meters replaced, 4 meters read/re-read, 0 main repairs, 1 service line repairs, 1 customer inquiries requiring investigation, and 0 sewer issues/repairs. There were also 7 new owners, 1 lien filed, 1 lien released, 60 shut-off notices, 13 non-payment shut-offs, and 10 turn-ons after water shut-off. In December, there were 8 customer requests to turn off/on water, 1 District initiated shut-off, 0 District equipment repairs, 0 meters replaced, 0 meters read/re-read, 1 main repair, 2 service line repairs, 0 customer inquiries requiring investigation, and 1 sewer issues/repairs. There were also 4 new owners, 1 lien filed, 1 lien released, 64 shut-off notices, 16 non-payment shut-offs, and 17 turn-ons after water shut-off.

Supervisor Miller also reported on the snow storm over Thanksgiving and the effects on the District.

- B) Chief Ozias reported on the Fire Department calls for the month of November and December. In November, there were a total of 7 calls, 6 were in-District and 1 was out-of-District. In December, there were a total of 9 calls, all 9 were in-District. Chief Ozias also reported that the Fire Department had their annual Christmas party, that the department participated in a structure fire in Running Springs, and updated the Board on the status of the newly obtained strike vehicle.
- C) General Manager Huff reported that he met with the County of San Bernardino utility coordination group. General Manager Huff reported that re-paving of the streets in Arrowbear Lake would begin in August 2020. General Manager Huff also reported that a new lift station controller was installed, and that Running Springs Water District did not need any water at the present time.

President Bunyea excused any individuals who were not required for the balance of the meeting.
