## SAS acknowledges an unsung hero, the Shenandoah Community Foundation

Early in 2020 at the start of the COVID-19 pandemic, the Shenandoah Community Foundation (SCF) reached out to service agencies in the community inquiring about ways it could help. I received a call from Michael Funk, president of SCF, asking about the kind of requests we were receiving during the pandemic.

I told him that, although we had received additional funding from federal and state sources, use of these funds is limited. Our federal and state funds will assist only when there is an eviction notice or if a family is literally homeless. I explained that all evictions were under a moratorium and that utility companies were forgiving past-due bills. But the requests we were getting were from individuals and families struggling to keep up to date on their current rents and other bills due to loss of employment, reduced hours, illness, and/or being forced to choose between going to work or staying home with their children as daycares and schools were closed due to the pandemic.

SCF immediately developed a program to help fulfill these requests and collaborated with all the non-profit organizations in Shenandoah County to meet the emergency needs of community members who havebeen affected by COVID-19. I can't speak with other non-profits, but this outreach meant more than just providing streamlined funding to the community. It gave us hope that this is not our fight alone. We were forcedbbecome more innovative in ways to serve our clients and how to supplement our federal and state funding with local funds to stretch the dollars and assist multiple families and individuals facing potential future eviction or loss of utility services, such as electric, water, or their heating source. The collaboration grew strong between all the non-profits and we all were working together to meet each need that came across our desks.

Shenandoah Community Foundation immediately implemented a grant application process entitled COVID-19 Emergency Relief Fund for Shenandoah County. We applied immediately and received \$10,000 to assist any or all Shenandoah County residents struggling with stabilizing their housing during the pandemic. We received two additional awards in 2020 for COVID-19, totaling \$20,000. These grant awards assisted 30 households of our neighbors, residents of Shenandoah County struggling to make ends meet duringthis national pandemic. In helping tenants pay their rent and stabilize their housing and keep their utilities on, funding gets paid forward to the landlord of these properties, the utility companies that employ our residents, and staff at the non-profits and state agencies such as the Department of Social Services. This grant program and gesture saved our community and bless the donors that give and support the Shenandoah Community Foundation. There is no question in our mind or the consumers we serve, you have made a huge difference in their lives and our community.
