For and in consideration of The Active Suncoast Foundation, Inc allowing me, the undersigned, to participate in the Shark Fin 5K and/or Shark's Tooth race weekend event(s) and its pre- and post-race activities (the "Event"), I hereby agree to and make the following contractual representations pursuant to this Agreement: I hereby represent that I am at least eighteen (18) years of age and have full legal authority to complete this event registration on behalf of myself and/or any other party I am registering (the "Registered Parties"). If I am registering a child under the age of 18 or an incapacitated adult, I represent and warrant that I am the parent or legal guardian of that party and have the legal authority to enter into this Agreement on their behalf and by proceeding with this event registration and participation in the event, agree that the terms of this Agreement shall apply equally to all Registered Parties.

I represent and warrant that I am in good health; I am in proper physical condition to participate in the Event and I have not been advised otherwise by a medical practitioner. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event standor is a chromoded gent and participating in the Event and/or its related activities involves an above-average risk of personal injury and dangers which include, without limitation, the potential for serious bodily injury, permanent disability, paralysis and loss of life; loss or damage to equipment/property; exposure to extreme conditions and circumstances, contact with other participants, spectators, volunteers, animals or other natural or man-made objects; dangers arising from adverse weather conditions; imperfect course conditions; land, water and surface hazards; equipment failure;
