September 13, 2022

- 1. The meeting was called to order by Bill Ashby at 7:00 pm.
- 2. A quorum of the Board was present Todd Klyn, David Rosengrant, and Jamie Potter. Bill Ashby (Association Manager) was present.
- 3. The meeting notice was posted in accordance with Statutory requirements.
- 4. A motion by Todd Klyn to approve the 7/26/2022 minutes, second by David Rosengrant, motion carries.
- 5. Manager's Report Bill Ashby provided the Aging Report. He also discussed the benefits of drafting a Scope of Work for the Landscaping contract before it goes out to bid.
- 6. Officers/Committee Report
  - Architectural Committee Based on the ACC recommendation and report, a motion by Todd Klyn to approve/deny the requests noted in the report, second by David Rosengrant. The motion carried.
  - B. Grounds Todd Klyn discussed the failure of the irrigation pump even after repairs were made to it. At this time, the zone irrigation system is not working because of the pump.
