Rev. Walter John Rothfuss, 71, of Bridgman, died Wednesday evening, April 30, 2008, at Jordan's Nursing Home in Bridgman, where he was recuperating after a short hospitalization. Walter was born June 25, 1936, in Pigeon, the son of Fred "Fritz" and Clara (Bauman) Rothfuss. He graduated from Pigeon High School in 1954. As a young man he loved to play and watch all sports. He was a people person, born to be a pastor. He believed strongly that the Christian faith must be lived out fully in daily life. (Teresa) Rothfuss and Doug J. Rothfuss, all of Union City; five grandchildren, Mike and Sara Mack, Russell and Trevor Sekeet, and Ami Eagen; four great-granddaughters; a sister, Marie (Paul) Leipprandt of Pigeon; and a brother, Joe (Veronica) Rothfuss of Caro.
