Police Report -

Chief Freyhof is applying for a grant to update the computers in the department. He applied and was accepted to attend the CLEE (Certified Law Enforcement Executive) program at no cost, classes start December of 2018 and run through January 2020. He reported on the recent Homecoming and Bicentennial Parades. He informed council that the LC Sheriff's Office has purchased a golf cart for the department that can be used for various events and asked if council had any interest in purchasing one for the village.

CITIZEN COMMENTS:

A. Ms. Theresa Johnston

Ms. Johnston, Mayor of Belle Center, is running for Logan County Commissioner. She introduced herself and gave a brief history of her background and asked for council support in the upcoming election.

OLD BUSINESS:

A. Server for Municipal Building

Chief Freyhof & Mr. Weidner have received three quotes to have a server installed in the municipal building. The server will provide a secure firewall, continuous onsite and offsite backups of all computers on the network and village issued email accounts. They recommended contracting Trithium Solutions for the purchase and installation of the server, and contracting Focused Network Consulting Services for the installation of electric and running/rerunning of cables. The other two quotes received were slightly lower for the server and installation costs, but the monthly service fees were much higher. Council requested that the solicitor review the quotes and prepare any legislation that may be necessary for the purchase.

B. United Way Grant

Mayor Reames reported that the application submitted to replace the playground border was denied.

NEW BUSINESS:

A. Lands & Buildings Committee

A meeting of the Lands & Buildings Committee was set for Thursday, October 11, 2018 at 7:00 p.m. to discuss yard waste removal/disposal, repairs to the front of the municipal building, reupholstering of council chamber chairs, and extending the height of the radio station walls to the ceiling.
