Privacy Policy

Introduction

The ATSSA's ongoing commitment to protect the privacy and confidentiality of your personal information is addressed in this Privacy Policy. Our policy complies with the requirements of the *Personal Information Protection and Electronic Documents Act* of Canada13 and the Canadian Standards Association Model Code for the Protection of Personal Information.

The Privacy Policy explains our commitment to respect and protect your personal information. We want you to know why we need your personal information, how the confidentiality of this information is protected, and how you can find out what information about you is recorded.

Accountability

ATSSA is responsible for your personal information under its control. We have appointed the ATSSA Vice President as the person who is accountable for the Association's compliance to this Privacy Policy.

Identifying Purposes

We will identify to you the purposes for which personal information is collected by us at or before the time the information is collected.

Your File

Personal information is the information that relates to you, that identifies you as a member of ATSSA and that allows us to provide services and benefits directly to you.

The ATSSA collects and uses personal information for the following purposes:

- a. To process applications for membership or volunteerism.
- b. To compile profiles on directors and members of committees.
- c. To provide requested information (e.g. meeting/event information, brochures, newsletters, etc.)

- d. To process purchases such as; Tickets for activities/Events, Outings, or any other merchandise purchased or requested from committee members or the ATSSA web sites.
- e. To solicit and process donations.
- f. To issue invoicing and tax receipts.
- g. To process applications for funding (e.g. Apprenticeship Awards, Sponsorships, etc.) from the ATSSA.
- h. For any other purpose to which consent is given.
- i. To comply with the law

Of course, you can choose not to provide us with some or all of your personal information. However, this choice may not enable us to provide you with the membership or information that you requested or that could be offered to you.

Consent

Your knowledge and consent are required for the collection, use, or disclosure of your personal information. We only collect, use, or disclose personal information for purposes we clearly define to you. For example, when you become a member of the ATSSA, your name and address will be used for general mailing and renewal purposes.

We believe you would also expect us to contact you to advise you of new and existing services, upcoming events and benefits that may be of interest to you. From time to time, we will inform you of such services, events and benefits via direct marketing. Direct marketing material is usually delivered to you by mail, telephone or electronic means. You may choose not to receive these offers and have your name deleted from our direct marketing lists.

Third-Party Disclosure

The names, addresses and telephone numbers of our members may be transmitted to a trusted third-party mailing service in order to inform you of services that we offer (or that we and our partners jointly offer) and/or upcoming events that we believe may interest you. We require our partners to have a policy in place that complies with the requirements of applicable federal or provincial privacy legislation in Canada and the Canadian Standards Association Model Code for the Protection of Personal Information. Except as required by law, ATSSA does not sell or disclose any of your personal information to any other organization and ATSSA will not transmit personal information to third parties without first obtaining your written consent to do so. From time to time, the ATSSA may disclose personal information to volunteers/staff who act as adjudicators

on behalf of the ATSSA in the assessment of applications for funding or to assess applications to volunteer.

ATSSA may, however, disclose information to third parties in the following cases:

- 1. to our lawyer;
- 2. to a police force, if required by law;
- 3. to a person authorized by law;
- 4. to a government agency which can oblige us to do so;
- 5. in emergency situations in which the life, health or safety of a member is in jeopardy;
- 6. to all other persons authorized by law

Limiting Collection

We only collect the information that we need in order to deliver services and benefits to you. We do not use techniques or other methods to collect personal information about you without your knowledge.

Limiting Use, Disclosure, and Retention

We do not use or disclose your personal information for any purposes other than those for which it was collected, except as required by law or with your consent.

Retention: Your personal information is retained only as long as necessary for the fulfillment of those purposes. ATSSA does not keep your personal information if it is no longer needed for the purposes required or as required by law.

Accuracy

Your personal information is kept as complete, accurate and up-to-date as is necessary for the purposes for which it is to be used.

Safeguards

The ATSSA protects your personal information by using safeguards that are appropriate to the sensitivity of the information.

Our Directors and Officers Responsibilities

Each of our Directors and Officers is responsible for maintaining the confidentiality of all personal information to which they have access. We keep our Directors and Officers informed about our policies and procedures for protecting personal information. Where

necessary, our Directors and Officers are required to sign agreements to keep your personal information confidential.

Keeping Your Personal Information Confidential

Your personal information is secure within the ATSSA.

We have comprehensive security controls to protect against non-authorized access, use, alteration, duplication, destruction, or disclosure.

- 1. Our safeguards protect personal information against loss or theft, regardless of the format in which it is held.
- 2. We have strict procedures in place with respect to destroying, deleting or disposing of personal information when it is no longer required for the purposes set out in this policy, or by law.

Openness

We will make our complete policies and practices relating to the management of your personal information readily available to you upon your request.

Member Access

Upon request in writing, you will be informed of the existence, use, and disclosure of your personal information and you will be given access to that information. We will assist any member who informs us that they need assistance in preparing a request concerning personal information. You may challenge the accuracy and completeness of the information and have it amended as appropriate.

According to privacy legislation, ATSSA has thirty (30) days to reply to a request for access to a file, except under the circumstances set out in s.8(4) of the Personal Information Protection and Electronic Documents Act.

Accuracy of Your File

You can ask to delete or correct any information contained in your file. The request for correction must be made by writing to us either by mail at the above-mentioned mailing address or by email at the above-mentioned email address. The ATSSA will reply within thirty (30) days.

Challenging Compliance

You can address any concern you may have regarding our compliance with this Policy to our Vice President.

Internet Related Policies
