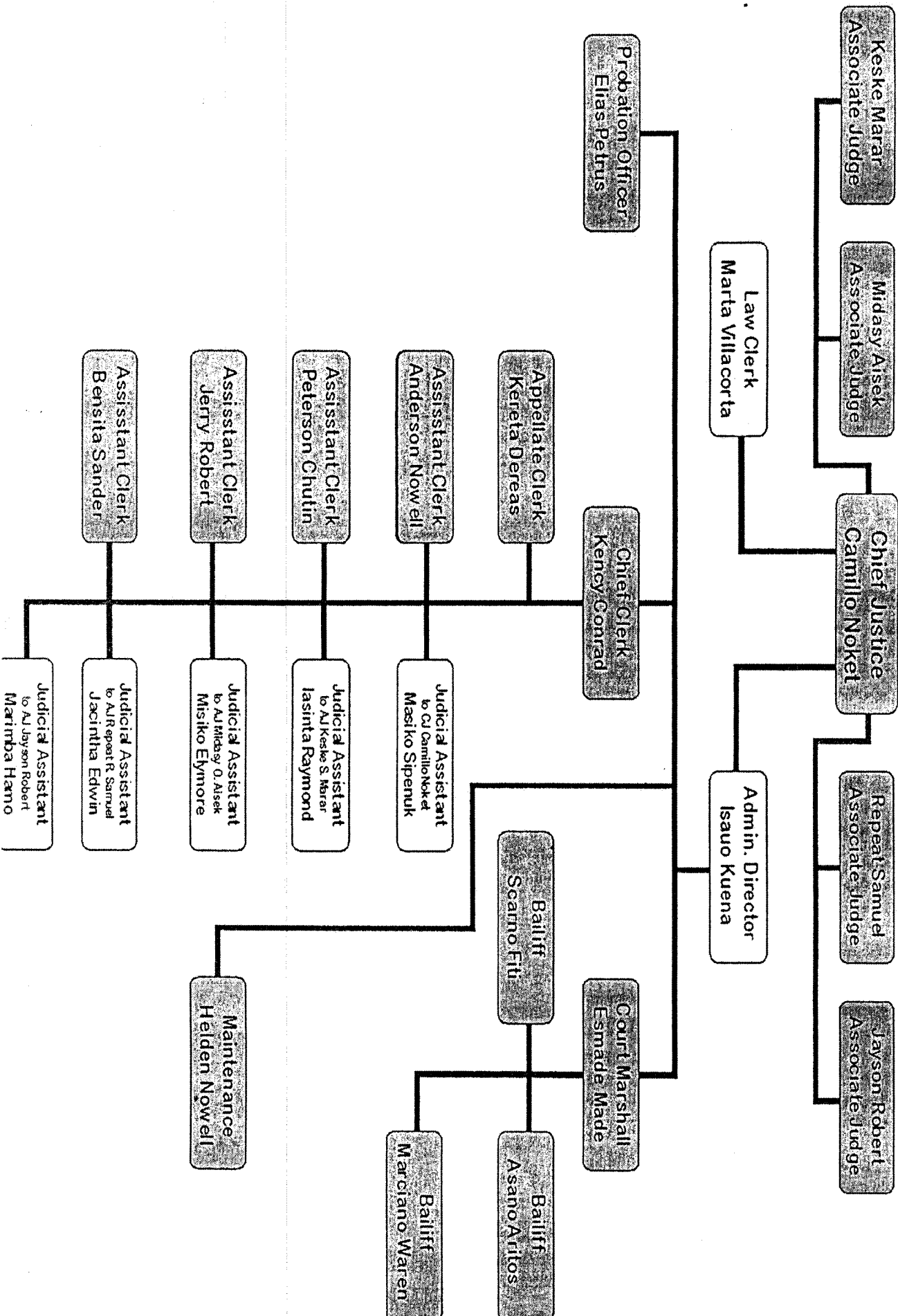

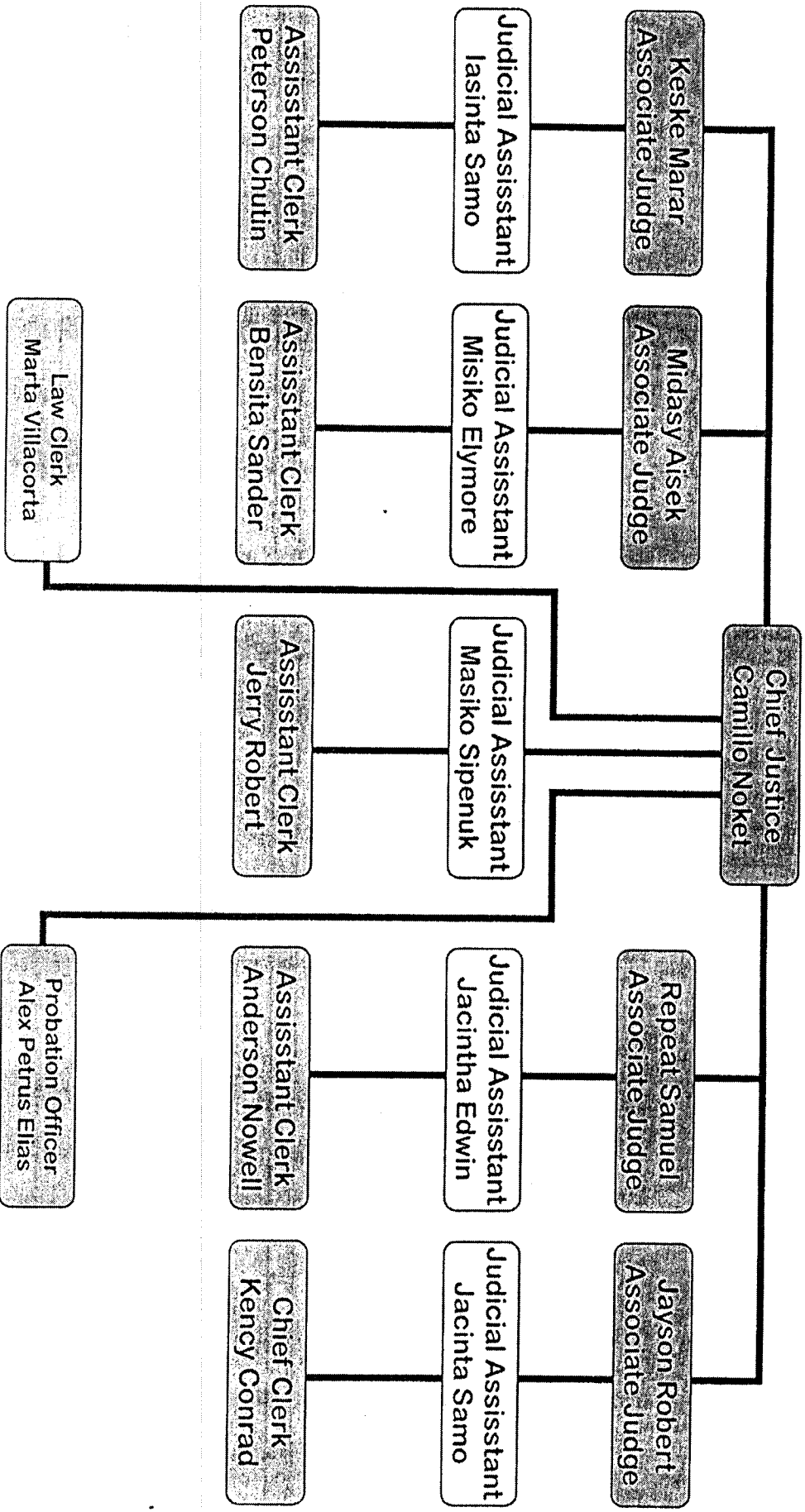

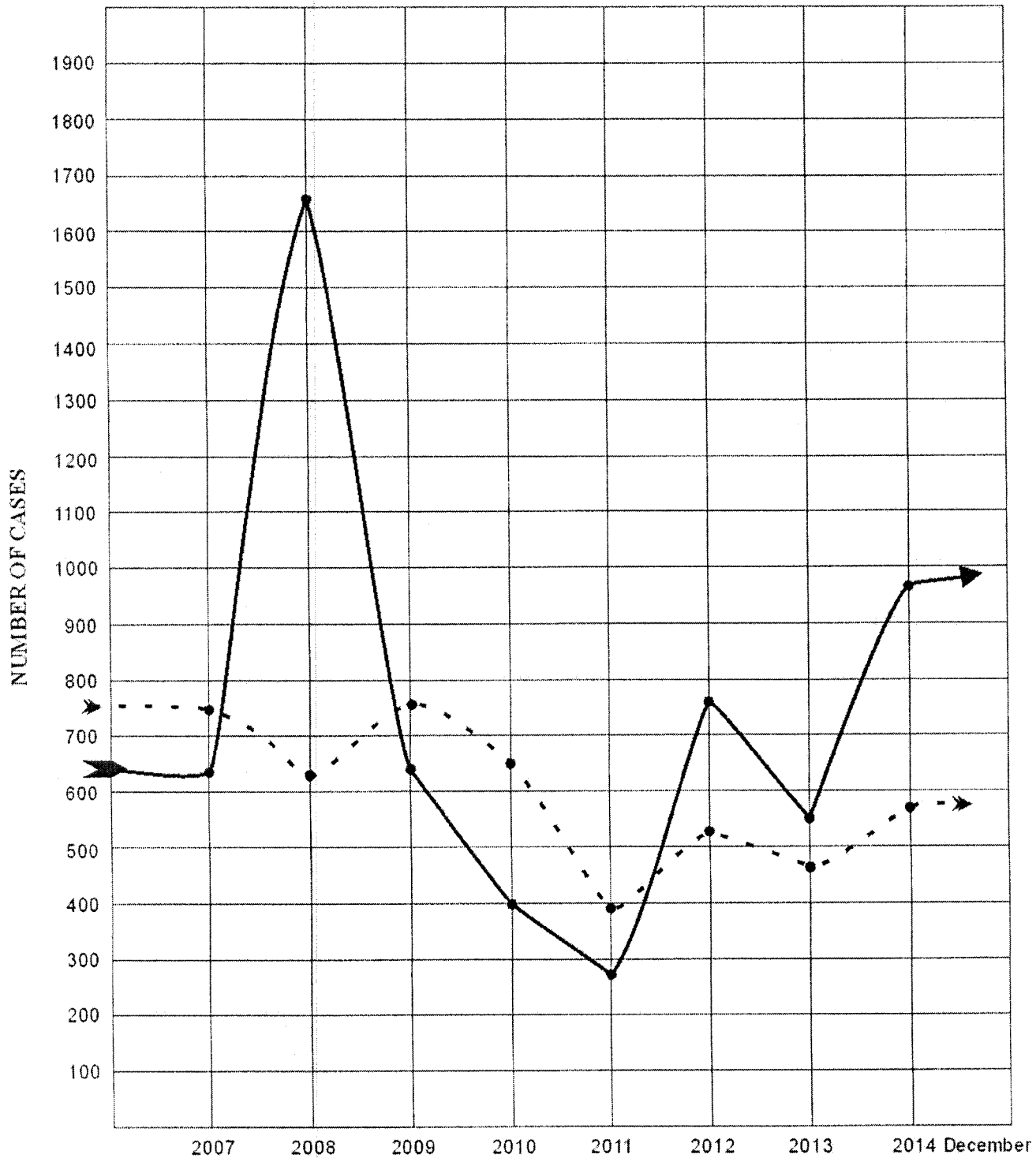
# Chuuk State Supreme Court Administrative Organization Structure

The Chuuk State Supreme Court, pursuant to the Chief Justice’s rulemaking authority under Article VII, Section 13 of the Chuuk State Constitution, and in recognition of its obligation to conduct a fair trial in a reasonable time, has developed Timeline Standards for management of all cases from the date of filing to disposition. The Timeline Standards will improve the timely disposition of cases and ensure that the administration of justice to the public is not delayed.


The Clerk of Court shall be responsible for (1) monitoring compliance with the Timeline Standards; (2) creating and maintaining a record for each of the individual judges in connection with the Timeline Standards; and (3) reporting his findings to the Chief Justice every quarter.

Now, therefore it is hereby ORDERED that the attached Timeline Standards are adopted and shall be effective as of September 16, 2014 for the period of one (1) year.

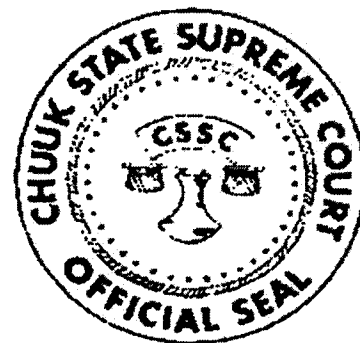

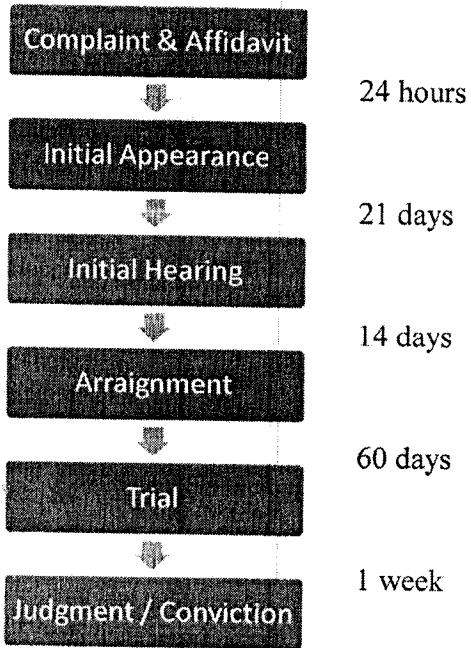

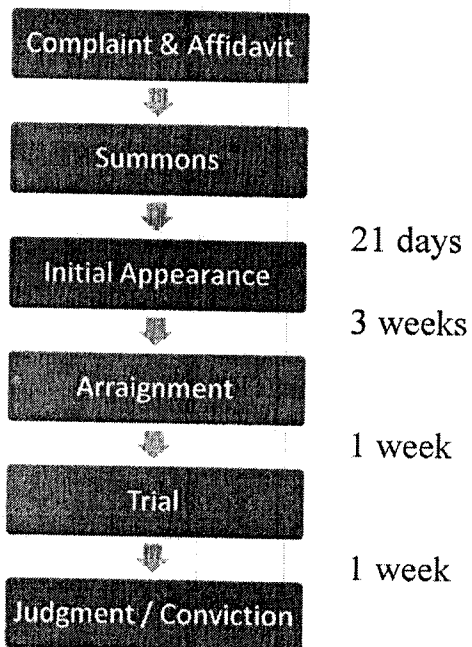
