You will receive your space assignment when you arrive; registration will be in front of the Larowe House. \*No Trailers are allowed in the arts/crafts and flea market areas. \* **PLEASE DO NOT SET UP PRIOR TO REGISTRATION**, violators may be asked to leave without refund.

Registration fee for participating is \$125.00 per space (\$135 after September 15.) There is a \$30.00 fee for each returned check. Sorry there are no one day fees. **A confirmation email will be sent to the email address provided above. If you would like one mailed to you please send a self-addressed stamped envelope.** If space is not available, your check or money order will be returned. **NO REFUNDS** will be given unless we are unable to honor your request.

As a vendor/exhibitor, I hereby agree to lease space at the Fall Foliage Festival's Arts & Crafts, Antiques & Flea market show to exhibit and sell merchandise on the 7<sup>th</sup> and 8<sup>th</sup> of October 2017, to be held in the Village of Cohocton, NY, 15 South Main Street – Rte 415. I waive and release any and all rights and claims for damage or injuries which may hereafter accrue to me against the Cohocton Development Corporation., it's members, officers, agents of the Village of Cohocton or Town of Cohocton for any damages or injuries which may be incurred by me in connection with my association with entry in or return from said event. We are not allowed to permit selling directly **from any vehicle** within or around the edge of the park. It is understood all exhibitors will furnish their own tables and/or display equipment, flies or tents. (Sorry, NO electric available and NO use of generators) Approximately 15ft of display frontage per space will be allotted each exhibitor. Space approximately 10 ft deep. We ask all our exhibitors to please keep ropes and stakes within assigned space. **You are expected to unload your vehicle from the nearest roadway. \*DO NOT PULL YOUR VEHICLE ON THE GRASS and remove it to the parking area prior to setting up.**

If you are selling homemade food products, you must send a copy of certificate of insurance and listing Cohocton Development Corp. as additional insured. You must also have proof of a current New York State Permit.

Alcoholic beverages, rummage, or used clothing, pets, firearms, hunting and military knives, swords, unsafe articles, pea shooters, snappers, tirebats, caps, fireworks, satanic paraphernalia, etc. **will not be permitted** on premises, or for sale in exhibit area. Other objectionable items will not be permitted under the discretion of the show committee.
