Ordinance #50 Weed, Rubbish, Snow and Ice Removal

This ordinance #50 is defined as follows: The snow, ice, or rubbish removal from sidewalks and weed elimination from street grass plots adjacent to sidewalks or from private property.

Section 1. Snow, Ice, Dirt and Rubbish. Subdivision 1A. Duty of Owners and occupants. The owner and the occupant of any property adjacent to a public sidewalk shall use diligence to keep such walk safe for pedestrians. No such owner or occupant shall allow snow, ice, dirt or rubbish to remain on the walk longer than 12 hours after its deposit thereon.

1B. Removal by City. The City maintenance Dept. shall remove from all public sidewalks all snow, ice, dirt and rubbish as soon as possible beginning 12 hours after any such matter has been deposited thereon or after the snow has ceased to fall. He shall keep a record showing the cost of such removal adjacent to each separate lot and parcel and shall deliver such information to the clerk-treasurer.

Section 2. Weed Elimination. Subdivision 2A. Weeds as a nuisance. Any weeds, whether noxious as defined by law or not, growing upon any lot or parcel of land outside the traveled portion of any street or alley in the City to a greater height than 12 inches or which have gone or are about to go to seed are a nuisance. The owner and the occupant shall abate or prevent such nuisance or such property and on land outside the traveled portion of the street or alley abutting on such property.

Subd. 2B. Notice. On or before June 1 of each year and at such other times as ordered by resolution of the Council, the Clerk-Treasurer shall publish once in the official newspaper a notice directing owners and occupants of property within the City to destroy all weeds declared by Subdivision 2A to be a nuisance and stating that if not so destroyed within ten days after publication of the notice, the weeds will be destroyed by the Maintenance Department at the expense of the owner and that if not paid, the charge for such work will be made a special assessment against the property concerned.

Subd. 2C. Removal by City. If the owner or occupant of any property in the City fails to comply with the notice within ten days after its publication, the city maintenance dept. shall cut and remove such weeds. He shall keep a record showing the cost of such work attributable to each separate lot and parcel and shall deliver such information to the Clerk-Treasurer.
