WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

Riders Against Domestic Abuse and Rape
Ride for Hope July 28, 2018

1. In consideration for participating in the R.A.D.A.R. EVENT, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE R.A.D.A.R., their officers, agents, servants, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being concluded.

2. I am fully aware of the risks involved and hazards connected with this activity, including but not limited to travel risks and/or tattoos/games. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.

3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs whatsoever, including court costs and attorney fees, that may be incurred due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise. This waiver includes all risks and/or liabilities, whether known or unknown, choate or inchoate, or whether reasonably foreseeable at the time of the signing of this waiver.

4. I understand that R.A.D.A.R. does not maintain any insurance policy, covering any circumstance arising from any participation in this event or any activity with or facilitating that participation. As such, I am aware that I should review my personal insurance portfolio.

5. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Idaho.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I executed this Release for full, adequate and complete consideration fully intending to be bound by same.
