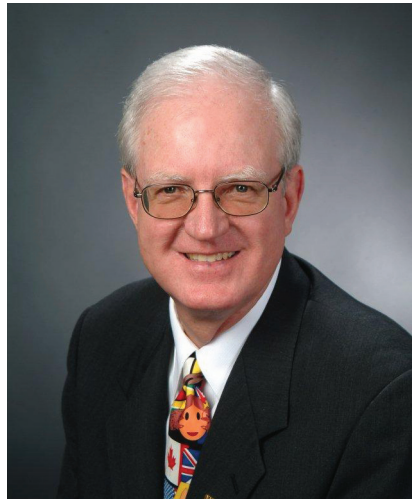

It is the mission of the Drug Court program to reduce the abuse of alcohol and other drugs and related criminal activity, and to help facilitate our participants’ recovery from alcohol and other drug abuse/addiction. ### Goals

- To provide a holistic system of care that will assist individuals, their families, and the community in recovery from alcohol and drug abuse/addiction disorders;

- To reduce the incidence and prevalence of substance use patterns and to promote responsible social behaviors;
- To provide employment and vocational assistance to participants in addition to traditional drug treatment services;
