

**HAMPTON TOWNSHIP  
ORDINANCE #2018-02**

**AN ORDINANCE TO AMEND CHAPTER 36, ENTITLED “ANIMALS”, OF THE  
REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF HAMPTON, COUNTY  
OF SUSSEX AND STATE OF NEW JERSEY.**

BE IT ORDAINED by the Township Committee of the Township of Hampton, County of Sussex and State of New Jersey, that Chapter 36 of the Code of the Township of Hampton, entitled “Animals”, be and is hereby amended as follows:

Section 1. Chapter 36, entitled “Animals”, is amended to add Article II, entitled “Hunting on Township-Owned Properties” which reads as follows:

ARTICLE II. Hunting on Township-Owned Properties.

Section 36-7. No Hunting Permitted on Township-Owned Properties.

No hunting of animals of any kind shall be permitted on any Township-owned property, subject only to the following exceptions:

- A. Although hunting snakes and reptiles on Township-owned property is not permitted, a person who is on Township-owned lands and comes upon a snake known to be deadly poisonous or a deadly reptile is not prohibited by this section from killing same on sight.
- B. Township-directed pest control on its properties is permitted.

Section 36-8. Violations.

Any person violating a provision of this Article shall, on conviction, be subject to the penalties and fines prescribed in Chapter 1 of this Code.

Section 36-9.

This Article is in addition to and not in derogation of any other ordinance involving or affecting any of the subject matters contained in the within Article.

Section 2. All provisions of Chapter 36 as amended hereby shall remain in full force and effect.

Section 3. This Ordinance shall take effect immediately upon its final passage and publication as required by law.
