Legislative News

We need to know our history; we need to share where we are at today, then be part of tomorrow's decisions for LPN and the caregivers in general.

Wisconsin Association Licensed Practical Nurses has in the mission to promote competence in nursing care, foster high standards of care, maintain Licensed Practical Nurse rights, and promote the LPN as a vocation. It is critical that every L.P.N. have a voice, by being a member of WALPN; you are part of the discussion and can have that unified voice for the focus of LPNs.

The history of LPN's dates back to the late 1800's. The LPN has always been flexible; but majority of focus has been the 'bedside nurse.' Each program heavily included numerous aspects of bedside care and expertise to accommodate that. Education, skills, and certifications have all evolved over the years. During World War II that included 'hardship tours' in Europe, North Africa, and the Pacific. Accreditation of practicing nursing schools in approx. 1945.

Our plate remains full today!

*August 19, 2019 Governor Evers appointed 29 persons to a Task Force on Caregiving. (Those names and titles will be under legislative link of the website). Their mission is to analyze strategies to attract and retain a strong direct care work force and support families providing caregiving supports and services. The task force has met twice. It is great to have the issue 'on the table' that said, it is complex and each LPN can offer assistance. Look up those 29 names and see who you are familiar with. Start a dialogue with them. Remember the first paragraph of this message and incorporate the LPN as an integral part of the process. This is not a spectator sport!

- *Share knowledge
- *Show facts
- *Share the need for quality safe care
- *There are over 11, 000 LPN's in WI, are they being utilized via the scope of practice?
- *Voice concerns you see happening now, give ideas of how to improve
- *Help them understand how the lack of Medicaid funding has adversely affected nursing homes.

MEDICAID

Some Administrations have chosen to try to eliminate the LPN. That has not been realized, some are now understanding to have a safe work zone, one needs licensed peoples with standards. As career options have increased over the past number of years, less people have chosen to be an L.P.N. People are more open that they don't care for with working weekends, holidays, overtime, short staffing, lack of respect, heavier work load, etc. Another major concern is the role that Administration is having unlicensed personal perform, thus they are 'practicing' under the license of an RN or LPN.

WALPN Legislative Committee

Current Legislative Session:

American Disabilities Act: Signed into law in 1990 by then President George H.W. Bush, over the past nearly 30 years, numerous strides have been taken. That said, we still have an issue in the current legislature. I ask that you watch October 10, 2019 assembly session on Wisconsin Eye. Please go the WALPN website and view data on legislative link. Here you can read "A matter of Human Dignity" published in the Eau Claire Leader. In-between watching Wisconsin Eye, reading the letter, and knowing what you do at work will give you power to know what some legislators' values are. Is it scary to you to know that politics means more the people?

If you have been to the Capitol you'll know ramps are in certain places, I have learned recently that 'way back in time' a legislator from the Sun Prairie area had a need for such and they did it!! Now we have the ADA, and games...

Wisconsin Center for Nursing

Assembly Bill 175 is in the works. It is to protect LPNs, RN, CNAs or anyone working in a healthcare facility and are attacked physically by patients or their families. If passed, this will be a Class H Felony, they have to intend to harm and know they are a healthcare provider. Governor Evers has set up a task force for Caregivers (non-paid) to get some type of payment for when they take care of their family members. This is a large undertaking and will be ongoing, as they have just started their task force.

The LPN Survey that each of you took to renew your license will be out later this month. Results will be in the February Capnotes.

Educational Corner

Type 2 Diabetes

Type 2 Diabetes is the most common form of Diabetes. This means your body doesn't use insulin properly and while some people can control their blood sugars with healthy eating and exercise, others may need medication or Insulin. There's NO one size fits all treatment for Diabetes, but we can help you to take each step forward. You have tools, resources, friends, family and healthcare providers. Know that you won't have to take this journey alone.

If you are newly diagnosed as having Type 2 Diabetes, do this following:

- 1. Learn about testing your bloods sugars, and research glucose monitors that will suit you.
- 2. Get more information on types of medication/Insulin, and how they work.
- 3. Know the 9 early warning signs and symptoms of Diabetes
 - a.) Frequent urination
 - b.) Increased thirst
 - c.) Always feeling hungry
 - d.) Feeling tired
 - e.) Blurry Vision
 - f.) Slow healing of cut/wounds
 - g.) Tingling/numbness or pain in hands and feet
 - h.) Patches of dark skin

Without treatment, persistent high blood sugars can lead to sever, sometimes life-threatening complications in:

1. Heart Disease

- 2. Stroke
- 3. Nerve damage, neuropathy
- 4. Foot problems
- 5. Kidney disease/can lead to Dialysis
- 6. Eye disease/loos of vision
- 7. Sexual problems for men and women

Untreated Diabetes can also lead to Hyperosmolar Hyperglycemic Non-ketonic Syndrome (HHNS). This causes increase in blood sugar levels during an illness or infection, and may lead to hepatization. This sudden complication usually affects the older person.

Anyone can develop Type 2 Diabetes, but certain factors incre4ase a person' risk factor:

- 1. Being 45 over older
- 2. Living a sedentary lifestyle
- 3. Being overweight or obsess
- 4. Eating unhealthily
- 5. Having family history of Diabetes
- 6. Having Polycystic Ovary Syndrome (PCOS)
- 7. Having a medical history of gestational Diabetes
- 8. Heart Disease or stroke
- 9. Being African American, Alaska Native, Hispanic or Latino, American Indian, Asian American, Native Hawaiian or Pacific Islander.
