The regular meeting was called to order on Tuesday, March 28, 2017 at 7:00 P.M. by Township Supervisor Allan with the Pledge of Allegiance. Roll call found all present.

A motion to approve the minutes of the meeting held Tuesday, March 14, 2017 as presented was made by Trustee Foley and seconded by Trustee Stack. Roll Call found all ayes on the motion.

Supervisor Allan asked all of the guests to introduce themselves.

Supervisor Allan announced that the Congressional Prayer Breakfast would be held on May 1, 2017 at 7:00 A.M. at the Collinsville Gateway Center.

The General Assistance bills for \$3,764.85 were read. A motion to approve the bills as read was made by Trustee Hill and seconded by Trustee Guy. Roll Call found all ayes on the motion.

The Road & Bridge bills for \$55,133.17 were read. A motion to approve the bills as read was made by Trustee Foley and seconded by Trustee Hill. Roll Call found all ayes on the motion.

The Townfund bills for \$52,480.77 were read. A motion to approve the bills was made by Trustee Foley and seconded by Trustee Guy. Roll Call found all ayes on the motion.

The Byron Senior Fund for \$376.34 was read. A motion was made by Trustee Hill and seconded by Trustee Guy to approve the bill as read. Roll Call found all ayes on the motion.

The Collinsville Township Pauper Fund bill for \$40.34 was read. A motion was made by Trustee Hill and seconded by Trustee Stack to approve the bill as read. Roll Call found all ayes on the motion.

Trustee Foley stated that he would like to straighten out some misinformation concerning the purchase of the UMB parking lot. Foley and Supervisor Allan explained the parking lot situation that dated back to 1994 when the building was constructed and a portion of the Township lot belonged to UMB and we have been dealing with them to try and get the parking lot repaired. Further details were given concerning the Environmental Study and the assessed value. The Board gave details of the purchase.

Supervisor Allan said they are now serving breakfast once a month at the Senior Center.

Highway Commissioner Trucano said his crew has been working at the Township office on re-modeling and landscaping. They also are trimming trees and changing needed culverts. Supervisor Allan thanked the crew for their work.

Trustee Foley said he talked to a person at the Center about restoring the grant for the Senior Meal Program..
