## AIRPORT ENGINEER'S REPORT

Nik Ipolitto, Dan Quirion and Matt Caron appeared on behalf of the airport's engineering consultant, Gale Associates, Inc.

## Runway Groove and Seal Project SBG 12-18-2016

Mr. Ipolitto provided an update on the Runway Groove and Seal Project.

- Phase I (COMPLETE)— Grooving work on the Runway was completed in five (5) calendar days.
- Phase II (Stoppage) Sealcoating, Inc. has completed sealing all project areas. The first coat of
  pavement markings has been installed and the Runway has been re-opened. Per the Contract,
  the second coat of pavement markings may not be applied until the sealant has cured for 30
  days.
- Gale conducted a site visit with Indus (Formerly Sealcoating, Inc.) and Sir Lines-A-Lot to discuss the remaining work, and the best methodology for preparing the sections that have peeled up to be remarked. The solution is to use a piece of specialty equipment to use pressurized water to remove the remainder of the markings and clean/prepare the surface. It is Gales intent to pursue the manufacturer (Asphalt Systems, Inc.) for the cost of the corrective actions. The warranty for the work has not started yet. Chairman Woods stated that he and Airport Manager Chris Lynch met with Gale and the timeline of all previous work has been recorded and the NAA is not expected to incur any additional cost.
- At this time, the Contractor is coordinating with sub-contractors to complete the remaining work. We will have a 14 day notice before the remaining work in started.

Recommended Actions: None at this time.

# Purchase Snow Removal Equipment (SRE) Project SBG 12-18-2018

Mr. Ipolitto provided an update on the Snow Removal Equipment Project.

- This project has been funded by NHDOT/BA and FAA.
- Milton CAT has received the Grader at their Londonderry, NH facility and is in the process of upfitting it with the required lighting, strobes, and retro-reflective markings.

# Pavement Reconstruction and Maintenance Phase II (NHDOT No. SBG-12-20-2019)

Mr. Ipolitto provided an update on the Pavement Reconstruction and Maintenance Phase II Project.

- All funding applications have been submitted to NHDOT/BA for this Project. The application
  package requests funds to cover the Base Bid and all alternate work items. Funding for
  construction is contingent upon the availability of discretionary funds from FAA. If FAA cannot
  issue funding for the entire Project, they may issue a grant for the base bid plus as many
  alternate work items that funding will permit.
- Gale is coordinating with Continental Paving, Inc. to determine a Project Schedule. However, this will be affected by the date the grant is issued. Gale will update the Authority when a schedule has been established.
