### Presentation

Al Waller, K3TKJ gave a presentation on powering the ham shack via solar panels.

Most solar panels available through www.amazon.com are manufactured in China. Al purchased some panels and constructed a home-made mount for them. A 2' x 4' panel yields 100 watts.

Solar panels behave like a battery. 100 W = 20 V at 5 A. Hooked in series, his panels yield 88 V at 5 A (400 W).

Panels are highly standardized, and use the same connectors.

A charger takes 22V and drops it to battery voltage. All has approximately 1000 amp hours of battery. No AC current is generated. The shack is all DC current. Anderson Power Poles are

used extensively. Panels are adjusted for summer & winter sun angles.

Harbor freight has a \$129.00 18.9V panel. Al demonstrated, on site, the small panel with an

inverter powering a desk lamp. Harbor freight has locations in Dover, DE and Salisbury, MD.

Various photos of grounding and the shack were shown. Images include vintage AM gear to

state of the art software defined Flex radio.

Al's power system has worked continuously for about one year.
