<u>Reminder – Contest to Close Gaps in Care –</u> \$5,000 Up for Grabs

Quality scores are integral to the success of an ACO. The Silver State ACO team, including quality coordinators, helps by identifying opportunities and ideas for closing gaps in care. Last year, we ran a contest for groups to improve their scores. The added incentive helped and the contest was successful. So, we are expanding the contest this year.

There will be a \$1,000 cash prize for the practice that completes the most screenings in each of five categories by October 31st: Depressions Screenings, Fall Risk Assessments, Diabetic Eye Exams, Colorectal Cancer Screenings, and Breast Cancer Screenings. A practice may win in any one – or all five – categories. That could mean anywhere from \$1,000 to \$5,000 for your practice. (YOU decide who gets it).

One month to go. These screenings are good for the patient and good for closing gaps in care. They could also be really good for your practice! Talk to your quality coordinator for more details, helpful hints and assistance.

Shared Savings Payments

CMS had predicted that by the end of September they would distribute funds to those ACOs that were successful and earned shared savings for 2017. As this newsletter "goes to press" we have just been notified that those funds have been received by our bank. It will take a few days for checks to be drawn. Practices who were part of Silver State ACO in 2017 should expect to receive their share of the Shared Savings Earned within two weeks. Congratulations!

New Medicare Cards - Progress Update

Beneficiary Identifier (MBI) numbers. These numbers are randomly generated and designed to replace HIC Numbers which included the beneficiary's social security number. Both the HICN and the MBI will be accepted by CMS until December, 2019. Thereafter, only the eleven character MBI will be accepted.

CMS began mailing new cards to Medicare beneficiaries in April 2018, rolling them out by geographic location. Now it's our turn. CMS has begun mailing new Medicare cards to beneficiaries in Nevada.

CMS will conclude mailing all cards by April, 2019. If any of your Medicare patients say they did not get a card by then, ask them to:

- Call 1-800-MEDICARE (1-800-633-4227). CMS will verify their identity, check their address, and help them get their new card
- Continue to use their current card to get health care services until they get their new card

Your Medicare patients should continue to protect their new number to prevent medical identity theft and health care fraud. CMS will continue to educate and raise awareness about potential scams and preventing fraud.
