**ORDINANCE NO. 2019- 01**

**AN ORDINANCE TO AMEND CHAPTER 184 “VEHICLES AND TRAFFIC”,  
SECTION 184-11 “PARKING PROHIBITED AT ALL TIMES ON CERTAIN  
STREETS” OF THE CODE OF THE TOWNSHIP OF BLAIRSTOWN**

**WHEREAS**, the Township Code contains a section regarding locations throughout the Township where parking is prohibited at all times; and

**WHEREAS**, upon the input of the Director of the DPW, the Township Committee has reviewed the current Code and determined that it is necessary to amend the Code section to add another location; and

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Blairstown, Warren County, New Jersey, that Section 184-11 entitled “Parking Prohibited at all times on certain streets” of the Code of the Township of Blairstown be an is hereby amended as follows:

**SECTION 1.** Chapter 184 “Vehicles and Traffic”, Section 184-11 “Parking Prohibited at all times on certain streets” shall be amended to read as follows:

A. No person shall park a vehicle at any time upon any streets or parts thereof described.

<b>Name of Street</b>	<b>Sides</b>	<b>Location</b>
Airport Road*	Both	Entire Length
Belcher Road*	Both	From Cedar Lake Road to the railroad culvert
Blair Place	Both	From Main Street to Millbrook Road
Bridge Street	West	From Douglas Street to Highway 94
Carhart Street	East	From Main Street to Vail Street
Cedar Lake Road *	Both	From Sand Hill Road to Airport Road
Douglas Street	North	Entire Length
East Avenue	South	Entire length
Gaisler Road, Cul-de-sac,	Both	Entire area of the curvature of the cul-de-sac at the termination of Gaisler Road
High Street	South	From the intersection of High Street and Millbrook Road (County Road 602) to the Blairstown Township/Hardwick Township municipal boundary line (said municipal line is situate 200 plus or minus feet west of the intersection of Millbrook Road and Stillwater Road (County Route 521)
Lambert Road*	Both	From Cedar Lake Road to Airport Road
Main Street	North	Area over Blair Creek
Noe Road	Both	From the intersection of Noe Road and Raub Road south to the point at which Noe Road becomes one way.

**NOTES:**

\*\*The Township Committee of the Township of Blirstown may provide for and regulate the parking of vehicles in areas so designated and marked.

B. Any violation of this section shall be punishable by a fine not to exceed \$25 or by imprisonment for a period not to exceed 10 days, or both.

All other portions of this Chapter remain unchanged.

**SECTION 2.** All ordinances or parts of ordinances of the Township of Blirstown inconsistent herewith are repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

**SECTION 4.** This law shall take effect immediately upon final passage, approval and publication as required by law.
