**NON-MEMBERS OF CHURCH:**

- 2 Day - \$2,300.00 \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**  
One installment deposit of \$230 due by Feb. 28, 2020, or with application. 9 installment payments of \$230 due the 15<sup>th</sup> of each month, September through May.
- 3 Day - \$2,725.00 \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**  
One installment deposit of \$277 due by Feb. 28, 2020, or with application. 9 installment payments of \$272 due the 15<sup>th</sup> of each month, September through May.
- 4 Day - \$3,200.00 - \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**  
One installment deposit of \$320 due by Feb. 28, 2020, or with application. 9 installment payments of \$320 due the 15<sup>th</sup> of each month, September through May.
- 5 Day: \$3,700.00 \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**  
One installment deposit of \$370 due by Feb. 28, 2020, or with application. 9 monthly payments of \$370 due the 15<sup>th</sup> of each month, September through May.

**One installment deposit, due 2/28/20 or with application, is refundable for 15 days after date of payment. If 15 days includes first day of school, there is no refund of tuition.**

**3 Day - \$2,575.00 \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**

One installment deposit of \$262 due by Feb. 28, 2020, or with application. 9 installment payments of \$257 due the 15<sup>th</sup> of each month, September through May.

**4 Day - \$3,000.00 \$75 Re-Enrollment Fee (for children currently enrolled) or \$100 Registration Fee (for all new students) due with Registration Form. These fees are non-refundable.**

One installment deposit of \$300 due by Feb. 28, 2020, or with application. 9 installment payments of \$300 due the 15<sup>th</sup> of each month, September through May.
