Petitioning for Park Safety

I recently contacted the Aurora Parks and Recreation department in efforts to address an ongoing problem in our neighborhood. The lighting for Sagebrush Park is not an effective deterrent to mitigate crime and other disruptive acts in Andover Glen and Woodgate communities.

PAR officer Richard Groom has mentioned that this park "is one of Aurora PD's biggest problems" in the city when it comes to crimes and other "vice oriented" activity. Currently, Sagebrush Park has only one dedicated light which is located in the far southwest quadrant, illuminating only 1/20th of the park.

I need your assistance to complete our efforts. A petition will be presented to the bordering residents of the park in an effort to confirm construction and placement for 1 light which is already approved by the city pending a successful petition. Please speak with your neighbors "on the park" and convince them of this need.

Lighting the park with as few as 3 additional lights would not only mitigate activity in and around the park, it would allow residences additional access into the evening to serve their needs as intended; in one phrase, it would become a safe park. Budget constraints only allow for one additional light. Please contact our Ward Councilman Bob Roth at 303-739-7510 or email: broth@auroragov.org and voice your support for additional lighting, with that effort and influence from our PAR officer, the city won't ignore Andover Glen.
