- No training of any kind in the ring. Bring your own water.

**DOS entries are 7:00 – 7:30 A.M. each day (provided trial is not full)**

Entries must be received by **July 19th, 2022, at the secretary's address.**

DOS \$25.00, DOS Jr. Handler \$15.00; PE \$20.00, \$17.00 2nd entry same dog/same trial pre-entry only. Pre entry Junior \$12.00,

Discount example. Ro2 and Ro3 same dog, same trial. If you are entering Rally each trial, one class would be \$100.00. If you are entering Ro2 and Ro3 each trial, would be \$25 plus \$17 each trial.

*Entries will run in "B" if no designation is indicated. It is exhibitors' responsibility to mark entry if requesting to jump minimum height in obedience.*
