2015 OAKLEY PARK PROJECTS

Throughout the season there may be times when Oakley Park is closed due to ongoing projects. Please do not allow your children to play with or on equipment and please keep them away from any areas under construction. A light post was recently installed at Oakley Park in March. The light is designed to help the sheriff's department and community volunteers visually see if people are loitering in the park after hours. All community parks close at dusk. The Board is also discussing surveillance options at this time. The concrete surround for the playground and cracked sidewalks were completed this month. The sidewalk going into the park was extended away from the pine trees due to damage. In the next few months the walking path will be sealcoated and the basketball court will be receiving its facelift. The basketball court will be transformed into two pickleball courts. Enough space will be left for a future pickleball court, surface volley ball net or badminton area depending on popularity. A fence will also be erected around the court and two player benches installed.

VANDALISM OR CREATIVE EXPRESSION

Saturday, April 11th between the hours of 4pm and 6pm \$1,300 worth of wet concrete was walked on, signed and damaged at Oakley Park. Photos of the damage are posted on the Benjamin Crossing website and the Eyes on Benjamin Crossing Facebook page. The concrete contractors were immediately contacted. A portion of the damage was repairable, but the concrete was already beginning to set. The legible names engraved into the wet cement were: Jashaun, Akeelah, Isabella, Fernando, and Keneray. Witnesses at the park advised that a gentleman was allowing his kids to run through the cement and write on it. It is the responsibility of anyone witnessing vandalism in our community to immediately contact the sheriff's department. The areas were visually marked off with yellow caution tape and staked around the wet cement. Board President, Destiny Ruby, reported that she was disappointed that someone would let their children destroy the concrete while sitting only a few feet away and those witnessing it didn't confront the parent or children. "It is unfortunate", she said, "this isn't just a community problem; this is an America problem. People these days, for whatever reason, are turning a blind eye when they see the law is being broken." Vandalism and damage to community property is against the law and as a community we have a responsibility to take care of the area we live. Children are not permitted at the parks, trails, greenspaces, Chilton circle or ponds unsupervised. Any adult witnessing a child unsupervised in these areas is encouraged to politely ask them to leave or to simply contact the sheriff's department and report it. A police report (#2015-1631) has been filed. Please contact Deputy Roozt at (765)423-9388 with information regarding this incident. If you are the parent of one of the children involved, please contact Management Advantage to discuss various community service projects that your child could perform as restitution for the damage to our community Common Areas.

COVENANT CORNER

Each quarter we highlight a topic to help keep our residents and owners better informed. But you don't have to wait for the NewsLetter, you can visit the website and browse the governing documents yourself.

COVENANT HIGHLIGHT:

Article IX Storage Sheds and Temporary Structures (Declaration§ 7.11) The Declaration prohibits detached structures, such as shacks, tents, trailers, storage sheds, and minibarns, on any Lot or on the Common Areas. The Declaration does not forbid attached structures.

An "attached structure" shall mean any structure that is built, constructed, erected or installed with a separation of no greater than six (6) feet of open space from the dwelling unless the structure is otherwise prohibited by the Declarations. This means that homeowners can have a shed on their property as long they are within six (6) feet of their house. Additional restrictions can be viewed in the Rules, Regulations and Procedures on the website. All attached sheds must be approved by the ACC Committee. 
She admits the original structure didn't fare well during the winter and is in the process of improving the library. While under construction she is still maintaining the library and keeping it well stocked with

We made it! We endured yet another brutal winter. While we know we made it, it's anyone's guess right now how many of our plants have survived.

Please don't be too hasty in digging out that lifeless looking tree, bush or flowering plant. Wait until the weather has warmed up and it has been given enough time to fully wake up and begin to open those leaf buds ----- yawn ----- stretch and start another year of life.

A perfect example of a plant that takes time to come "alive" in the spring is the flowering Hibiscus bush. Look for any new growth at the base of the plant - not on last years branches which really should have been cut off last fall when it died back after that first frost. Wait at least until mid-May before you get out that shovel.

Plants are expensive and add value to your home. So be sure it really dead before you dig it out.

It doesn't matter how much cleanup you did in the fall; spring is another busy time ----- pruning out dead or broken branches and burying those young plants that were heaved out of the ground - just to name a few.

Your plants have come through a miserable stretch of cold and sub- zero weather so now is the time to FERTILIZE - FERTILIZE - FERTILIZE!

You take good care of your plants and you will reap the rewards. Remember they can't run down to Burger King when they get hungry. HAPPY GARDENING!

TOWING & IMPOUND

The Association enforces CC&Rs Section 7.4 Parking and Prohibited Vehicles 1st Amendment through an agreement with J.R. Enterprises, Inc. The Association does not pay for this service and receives no remuneration in return. J.R. Enterprises receives payment directly from the individual that has violated the covenant through impound and storage fees. While it is commonly referred to as being towed any vehicle parked contrary to the Rules, Regulations and Procedures of Benjamin Crossing is actually *impounded*. These rules are published on the website and with the Tippecanoe County's recorder's office. Impound and storage fees are significantly different than a towing fee. By definition impound is to seize and take legal custody of a vehicle, because of an infringement of a law or regulation.

During the 2015 Annual Meeting homeowners addressed the Board with concerns about the fees charged by J.R. Enterprises. As a result the Parking Committee and Board have discussed set fees with J.R. Enterprises. These fees are below and are also published on the Benjamin Crossing website. The Board hopes that these set fees will eliminate concerns that the towing company is charging people differently. Always request and keep your receipt and if any person is charged a fee different than what is below, please contact Management Advantage for investigation. Should your vehicle be impounded the minimum charge will be \$139 or \$184 with an "after hours" fee.

Benjamin Crossing Impound Fees:

Impound Fee with/without Equip....	\$85
Mileage Charge.....	\$35
Storage Fee Per Day*.....	\$20
After Hours Release**.....	\$45
Drop Fee with/without Equip.....	\$80

*Storage fees occur as soon as the vehicle is on the lot and ends at midnight. A new fee will then be added for the next day.

**After hour release is anytime after 5pm and weekends. Normal business hours are 9am-5pm M-F.
