**Meeting Minutes:** A motion to accept the April 29<sup>th</sup>, 2019 Meeting Minutes was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0.

**Treasurers Report:** The beginning balance for May 2019 is \$44,438.76, receipts of \$6,081.59, expenses of \$21,053.03 and ending balance of \$29,467.32. A motion to accept the Treasurers' report was made by Joe Hickman, 2<sup>nd</sup> by Jane Hurley and carried 3-0.

**Old Business:**

- 1) Fred Bonk discussed creating a driveway requirement. Marysville will create a form of driveway requirements and have Ron & Bob use and inspect the driveways requirements will be our standard requirements of a culvert minimum of 30 feet, 15", steel with flares. Once it is developed, we will let Wright County Planning and Zoning know.
- 2) Joel & Beth Ebert of Endicott Ave SW questioned what to do with the gravel run off the road into their driveway. The problem is there is no culvert under the driveway and the driveway is concreted to the road. A site inspection is scheduled for May 21<sup>st</sup> at 4pm.
- 3) The Township Board discussed Desoto Ave road as well and the site inspection of Desoto Ave is scheduled for May 21<sup>st</sup> at 4:30pm.

**New Business:**

- 1) Augie Riebel worked with Century Link's request to do work in the ROW. A \$10,000 bond was received along with site plans indicating directional bore. A motion to allow the ROW work was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0.

- 1) A motion to have B. McNamara haul gravel for \$8.04 a yard for 4,000 yards was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0. Gravel hauling will start May 28<sup>th</sup>.
- 2) Dust Coating will start this week.
- 3) Karen Fadden who is involved with the Waverly Celebration was present along with Gloria Janikula, Woodland Township Clerk. Karen is doing research on Marysville and Woodland communities. She will have a booth during the Waverly celebration that highlights the century farms and churches with both Townships.
