# **Public Participation:**

### **Police Report:**

Office Turek presented the October Police Report to the board, 13 calls were answered in Washington Township.

As discussed the two properties that are nuisance violations, one property located at 461 Farmers Turnpike had burned down, and the rubble is being cleared from the property. The Scanlon Hill Property is to be investigated by the Cresson Township Police. The Scanlon Hill property has had in the past bee hives removed from the property as well as, ferrell cats, and one abandoned vehicle and numerous other nuisance violations. Cresson Township Police given a copy of the letter sent to property owner from Washington Township Supervisors.

As discussed the Fuchs fencing project along Farmers Turnpike, fencing is complete and 2 cars still need to be moved into the fenced area, the two vehicles reported earlier to be infested with bees. Cresson Township Police to make sure these cars are moved into the fenced area.

As discussed the boundary line issue between Washington Township and Portage Township, recently in this area a vehicle accident occurred, there was confusion as to which EMS to contact, due to a missing Washington Township boundary line sign. A meeting has been set up between Washington Township and Portage Township along with surveyor Fred Brown to solve the boundary line issue, 8 Am November 11<sup>th</sup>, 2009 at the Portage Township Office.

### **Engineers Report:**

As discussed the finalization of contracts with D. T construction, reviewed with the Cambria County Redevelopment Authority, Mr. Custer agreed that there was not pending issues, contracts are finalized.

As discussed stimulus funding that may be available for the Upper Dutchtown Water Authority and Washington Township perhaps to create a water authority, we would have to demonstrate a clear control of financing and both sides identify and agree to a point to which transfers occur.

#### **New Business:**

Barry Walters has contacted the township through the Roadmaster asking about the turnaround located on his private property. Washington Township no longer goes past the 1<sup>st</sup> turnaround located on Red Dog Lane; Mr. Walters's wishes to gate off/fence the property off. Solicitor suggests a copy of the most recent survey be given to the Washington Township Supervisors before any decisions are made. Tabled until December 2009 meeting.

As discussed Steve Sewalk from the EADS Group and Debra M. Walter, Program Manager with the Johnstown Redevelopment Authority will meet Tuesday, November 10<sup>th</sup>, 2009 at the Washington Township office, to discuss the future development of the Regional Recreation Center through funding and grants, with an on-site visit.

James Brokenshire representing Duke Energy in conjunction with Sybil Cioffi about Washington Township's Land and Sub-Division Ordinance, Duke Energy asked if the township would incur the cost for the subdivision, since the land is being proposed for leasing. Phone messages were exchanged but no formal decisions have been made.

**Motion** made by Jaime Hartline 2<sup>nd</sup> Leslie Devett to authorize advertising for a Special Meeting for the purposes of establishing a lease with Duke Energy and any bidding that may required, if necessary. Roll call, All in favor, Motion passed

Ryan Street-Lilly borough is establishing new water lines in this area, there are 3or 4 homes located in this area whose water lines need to be replaced as well. Washington Township and Lilly Borough Water Company need to work together to complete this project and supply all home owners with water taps to the main line, instead of branching from house to house.
