Dear Innsbrook Community Member,

The Village of Innsbrook understands there is a great deal of information that is currently being thrown at us at an alarming speed. We want all of our community members to know, we are all in this together. The Village of Innsbrook will strive to provide accurate information in the form of an E-Newsletter, like this one, on a weekly basis until we see a flattening of the curve of COVID-19. Please have patience with us and one another during these trying times. It is our hope, we will all make it through this pandemic unscathed.

#### Statewide Social Distancing Order

On March 21, Governor Parsons directed the Director of the Department of Health and Senior Services to issue an order limiting social interaction statewide. This Order expires April 6, 2020 unless extended.

- Gatherings of 10 people or more prohibited: The Director's order provides that "every person in the State of Missouri shall avoid social gatherings of more than ten (10) people." This includes "any planned or spontaneous event or convening that would bring together more than ten (10) people in a single space at the same time."
- Eating and drinking at restaurants and bars to be avoided: The Director's order also states that every person in Missouri shall "avoid eating or drinking at restaurants, bars, or food courts." The use of drivethru, pickup, or delivery is allowed.
- No visitations to nursing homes: The order further provides that people "shall not visit nursing homes, long-term care facilities, retirement homes, or assisted living homes unless to provide critical assistance."
- > Schools closed: Schools shall remain closed statewide.
- Visits to grocery stores, banks, parks (for solitary exercise), gas stations still permitted with social distancing.

#### **Board of Trustees Meeting Change**




