Minutes of December 18, 2023

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Jed Lamb, Sheila Lanning, Matt Combs and Lyn Ickes. *Motion* by Holmes with a second by Rollin to approve the minutes of December 4, 2023 as written. Roll call: three yeas. Checks 10522-10528 and payments totaling \$5,545.94 were approved for payment.

COMMITTEE REPORTS:

WATER- Lamb: meeting is 12/20/2023.

LORCO- Lamb: Discussed sending affluent to French Creek treatment location, details being worked out the would be positive for all parties including LORCO because it would effectively reduce the debt owed to Avon Lake. Ickes: any talk on LORCO taking sewers down Baumhart. Lamb: not yet.

AMBULANCE- Holmes: Calls out of Huntington for November = 10, year to date 93. Total calls 127 with total year to date 1311. Mileage for November 3,653, year to date 43,942. Maintenance cost November \$916.20 year to date \$27,825.56. New Ambulance bid, delivery by end of 2024 or beginning of 2025.

FIRE- Rollin- Working on programming radios, buying pagers to go along with radios. Wetherbee will represent at the Lorain County Commissioners upcoming meeting on County Radio purchase. Holmes: Ambulance will be represented by Hank.

OPWC & SWAC- Combs: Will probably apply for Hawley Road project, due date is 1/31/2024.

CEMETERY- Lanning: sent rates to Jared Smith of Lorain County Township Association per a request. Rollin: Wreaths Across America was a big success, there were 50 to 60 volunteers to lay 182 wreaths.

ROADS- Holmes: replied to email from resident Barbara Murray on the emergency closure of Griggs Road by the County. County has emergency bids out for the work that is anticipated to be done in 2024.

SAFETY SERVICE BUILDING- Ickes: presented a grant possibility from USDA Rural Development "Community Facilities Direct Loan & Grant". This grant/loan combination would be spearheaded by LMRE with input and assistance by the Township. The Township is above the medium household income levels but will meet with LMRE on 1/8/2024. How much is the Township asking Representative Stein for in grant money? *Consensus* to request \$750,000.00. Two quotes were discussed: Morton Buildings, Inc and MQS Structures, LLC.

EQUIPMENT- Combs: The tax credit was issue from Cummins. Rollin: are the park water fountains drained. Combs: yes.

ZONING- Klebow: sent report dated 12/18/2023. Discussion on filling Board vacancies for 2024. *Motion* by Lamb with a second by Holmes to send a letter to Todd Denes terminating his appointment to the Zoning Commission Board and thanking him for his time. Roll call: three yeas. Holmes: the person I asked to about being on the Commission declined but will think about the Appeals Board.
