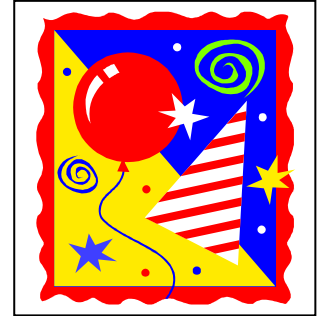

Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at LKSAGE@aol.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. Crating is on concrete around the periphery of the rings. **You may set up your crating space Thursday afternoon beginning at 4 pm.**

DIRECTIONS TO THE TRIAL SITE:

From I-5: Take EXIT 9 (in Washington), head West on 179th Ave. for ½ mile, turn left onto 2nd Ave., then turn left again at Gate 7. Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

MEASURING: We will have a VMO on site so all dogs without height cards will have to be measured, including the 24 & 26" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day near the trial secretary's table. It is your responsibility to have your dog measured BEFORE you run.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

VOLUNTEERS: We will be coordinating the worker schedule at the trial and will use the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with. Volunteers will get 1 raffle ticket for each class worked, for chances to win free entries. Drawing will be held at the end of the weekend. Winners will be notified via email/phone. Also, one \$3 "lunch ticket" per volunteer per day, for use at any participating vendor or toward a future entry.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, Dec 25, 2017 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

FOOD: Sweet AI's will be the food vendor on site and will be open from 8:00 am to the end of the trial each day.

As we are often preoccupied with trial and scoring duties, we may be distracted and wouldn't want to miss celebrating your Championship with you. So again, please come and remind us or send someone to remind us and we'll be ready with a ribbon.
