

Brew's and Props Artist Agreement for Poster Contest

Brews and Props is granted rights as follows for the following art work:

In consideration of the mutual promises set forth below, as well as other valuable consideration the Parties agree as follows:

- 1) Warranty. Artist warrants that she/he is the sole creator and owner of the original art work and that the work does not infringe upon any copyright, violate any property rights or contain scandalous, libelous or unlawful matter.
- 2) Indemnification. Artist will defend, indemnify and hold harmless **Brews and Props** and its representatives against all claims, suits, costs, damages and expenses that **Brews and Props** may incur for any scandalous, libelous or unlawful matter alleged to be contained in the work, or any infringement or violation of any copyright or property right
- 3) License Issue Fee. **Brews and Props** shall be granted the license by the artist for the sum of \$0 for license and use of the art work pursuant to this agreement.

Artist shall be awarded a cash prize for winning the contest. Prize to be awarded at the event in a sum not less than \$200.00.

- 4) Grant of Rights
 - a. Artist grants a non-exclusive license and right to **Brews and Props** to use, reproduce, display and distribute the art work in all materials created by **Brews and Props** regarding the **2018 Brews and Props** event. Artist permits **Brews and Props** to sell the artwork in posters. Should **Brews and Props** desire to use the artwork for any other project, the artist will be contacted for additional permission(s). **Brews and Props** may use the art work in and for promotional material and set up about the event. Artist shall retain all rights in and to the original art work. **Brews and Props** will provide at least 1 sample of all finished materials containing art work to Artist for Artist's portfolio.
 - b. Posters. Artist grants **Brews and Props** the right to reproduce and distribute a total of 50 numbered and signed posters and 50 unsigned posters featuring the artwork. Artist shall sign and number a total of 50 fine art posters containing the art work for use and sale by **Brews and Props**. Artist shall receive a total of 20 un-numbered fine art posters

Poster artwork is due no later than July 1 at 3pm.

Judging will be in July – date to be determined and artwork will be used immediately on marketing materials – flyers, brochures, labels, stationary, advertisements etc.

Artwork should be signed in the artwork so credit is given to the artist always.
