

ORDINANCE NO. 95-002
PALOS FIRE PROTECTION DISTRICT
RELATING TO VEHICULAR FIRE CALL CHARGES AGAINST NON RESIDENTS
OF THE DISTRICT

IT IS ORDAINED, by the Board of Trustees of Palos Fire Protection District, pursuant to the powers vested in said District under 70 ILCS 705, "AN ACT IN RELATION TO FIRE PROTECTION DISTRICTS," as follows:

SECTION 1: The board of trustees of a fire protection district may assess charges for all services rendered by the district against persons, businesses and other entities who are not residents of the fire protection district.

SECTION 2: Palos Fire Protection District responds to vehicular fire calls with its equipment and personnel to victims and property in need of fire services although from time to time it is rendering assistance to persons, businesses and other entities who are not residents of the fire protection district.

SECTION 3: The taxpayers of Palos Fire Protection District incur the expenses of providing fire service calls within its territory and it is therefore necessary and appropriate for the District to charge an amount that the Board of Trustees ordains to be a reasonable and customary cost to persons, businesses and other entities who are not residents of the Fire Protection District for its fire equipment and personnel.

SECTION 4: Palos Fire Protection District has determined that a reasonable and customary charge pursuant to this ordinance for non residents be as follows:

A charge shall be assessed and billed in the amount of \$750.00 to persons, businesses and other entities who are not residents of the Fire Protection District for each individual vehicular fire call rendered by the Fire Protection District.

SECTION 5: The charges provided for pursuant to ordinance 91-003 for ambulance service shall be in addition to the charges under this ordinance 95-002.

SECTION 6: To the extent permitted by law, the District shall seek reimbursement for all costs of collection of delinquent charges under this Ordinance not paid to the District within

30 days of the issuance of a billing for said charges. Costs of collection may include all reasonable attorneys' fees and court costs incurred by the District.

SECTION 7: This Ordinance shall be in full force and effect ten days from and after its adoption, approval, and publication, as provided by law.

SECTION 8: Ordinance 93-003 adopted on June 7, 1993, is hereby repealed effective ten days from and after the publication of Ordinance 95-002.
