All items below must be completed BEFORE move out or the cost to do so will be deducted from security deposit

- 1. All damage must be repaired properly
- 2. All hard floors must be swept or vacuumed and mopped
- 3. All carpeted floors must be vacuumed and cleaned using a carpet cleaner (all stains must be removed)
- 4. All cabinets must be cleared out and wiped down (all tack paper must be removed)
- 5. All sinks, tubs and toilets must be cleaned
- 6. All appliances must be cleaned out and deodorized
- 7. All walls must be cleaned
- 8. All baseboards, woodwork & windowsills must be cleaned
- 9. All interior and exterior light fixtures, switch plates and fans must be cleaned or replaced if needed
- 10. All areas behind and between appliances must be cleaned
- 11. Remove all personal property including any storage areas and remove all trash from property
- 12. All closets, shelves & rods must be cleaned
