This 4 day show, an All American Class A Show, features draft breeds such as Belgians, Clydesdales, Percherons, Shires and even Mules performing in various events from halter, hitching, plowing and pulling and riding classes. Over 1,200 horses and mules travel from around the USA and Canada to compete in this prestigious annual event.



West Nile Virus (WNV)

Latest News: On October 10, the Michigan Department of Agriculture and Rural Development was notified of a confirmed case of West Nile virus (WNV). This is Michigan's first reported case of WNV in equine for 2016. The affected horse is a five-month old filly in Calhoun County. On October 2, the filly began to develop signs of illness, including stumbling and lethargy. The unvaccinated filly is responding to treatment. The dam was vaccinated against WNV two weeks after foaling, and the filly is not yet weaned.

West Nile Virus (WNV) is caused by a virus that primarily infects and multiplies in birds, which serve as reservoirs for the virus. The virus is spread between birds through the bite of an infected mosquito. Like EEE, WNV requires a bite from an infected mosquito and cannot be transmitted directly from infected horses to other horses or humans. Mosquitoes can spread the disease to humans and other animals, including horses. Mosquito precautions for horses are recommended and horses should be annually vaccinated against the disease. Taking steps to prevent standing water where mosquitoes can breed, such as by frequently changing the water in bird baths, planter trays, and animal water bowls/troughs, as well as removing old tires and filling





puddles, is also advised.
