The ring layout, order of classes and additional details will be provided via email to “working spot” participants upon registration.

An “auditing spot” may observe all aspects of the workshop but will not participate in the practice judging portion of the workshop.

Take I-71 S towards COLUMBUS. Take the I-270 exit, EXIT 119A, toward AIRPORT/WHEELING. Merge onto I-270 E. Take the ALUM CREEK DR exit, EXIT 49, toward OBETZ. Turn RIGHT onto ALUM CREEK DR. Turn LEFT onto E WILLIAMS RD. 2164 WILLIAMS RD is on the RIGHT.

##### **From the South**

Take I-71 N towards COLUMBUS. Take the I-270 exit, EXIT 101, toward WHEELING/DAYTON. Merge onto I-270 E via EXIT 101B toward WHEELING. Take the ALUM CREEK DR exit, EXIT 49, toward OBETZ. Turn LEFT onto ALUM CREEK DR. Turn LEFT onto E WILLIAMS RD. 2164 WILLIAMS RD is on the RIGHT.

##### **From the East**

Take I-70 W towards COLUMBUS. Merge onto I-270 S via EXIT 108A toward CINCINNATI. Take the ALUM CREEK DR exit, EXIT 49, toward OBETZ. Turn RIGHT onto ALUM CREEK DR. Turn LEFT onto E WILLIAMS RD. 2164 WILLIAMS RD is on the RIGHT.

##### **From the West**
