A-Base Meter Changeover

To respond to advancing technology that allows for easier meter reading and communications, West Wetaskiwin REA embarked on an A-base meter replacement program. I am pleased to report that 36 meters were successfully replaced in 2022 further modernizing our distribution system. Your Board of Directors is focused on replacing a portion of the remaining A-base meters in the REA area each year until they are all modernized.

Vegetation Management

Annually, we address vegetation management both the comprehensive program to maintain a reliable system and the maintenance cost to do so. Later this evening Battle River Power Coop will be presenting a detailed report on this topic. For

Power Pole Update

Keeping utility poles in shape is critical component of providing reliable electricity to members. This is accomplished in two parts – first, poles are tested and those requiring change out are identified and the Board budgets for replacements accordingly. In 2022, approximately 130 poles were identified and replaced (both transformer and standard poles).

Distribution Tariff

Our goal, as your Board of Directors, is to safeguard the future success of the West Wetaskiwin REA and to ensure our members receive reliable, cost efficient electricity delivery. During our strategic planning to meet those goals, the Board is considering an increase in the Distribution Tariff for 2023. We did not reach this conclusion lightly. We had to consider the increased vegetation management cost to retain system reliability and the increased cost for pole changes. The end result is a need for a fair increase to continue our financially stable status.

Wire Owner Agreement Renegotiation and FortisAlberta Application

We have reported on this application to the AUC by Fortis for rate increases they claim results partly from our intermingled systems. This would affect all REA's and their members and we have joined forces with fellow REAs and the Alberta Federation of REAs to dispute Fortis' claim. As a partner in the proceedings we receive regular updates from the Contract Policy Sub-Committee on the status of the application and accordingly pay towards the legal costs to argue this case and its premise. Legal fees to fight this case also increase our annual costs.

Updated Electric Service Contract Coming

Our ever changing industry has revealed gaps in our current Electric Service Contract (ESC) which need to be rectified. The ESC will be revised over the next year with the intent to have every member sign an up to date ESC once the new version is finalized.

Distribution Tariff Update

As outlined in the President's Report and presented to the members at the AGM, the Board has determined that an increase would be required in the Distribution Tariff (DT) to maintain annual operations for the REA to provide safe, reliable electricity delivery to members. Additionally substantive legal costs are being incurred for external influences, namely to intervene in FortisAlberta' s application to change the terms in the renegotiation of Wire Owner Agreements, an action if approved would substantially increase member costs. The Board of Directors determined a nominal 5% increase would apply as follows.

Regulated Rate Option The Regulated Rate Option (RRO) may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather is a default rate. If you do not have a contract with an electricity retailer, then you are on the RRO. For April 2023, the RRO is priced at \$0.15633 per kWh, reflected on your enclosed orange bill. For May 2023, the Battle River Power Coop monthly RRO billing rate is \$0.14207.
