### WAIVER OF LIABILITY

As a member of the Hot Springs Village Anglers Club, Inc. an Arkansas non-profit corporation, and in consideration of my obtaining the rights and privileges of membership of the group, I agree as follows:

1. I understand that neither the corporation nor the officers, directors, chairpersons and coordinators of events (all herein referred to as officers) and members can act as an insurer of my safety, and in the event of boating or other accidents, I waive my rights to make any claim against either the corporation or any of its officers, unless such officer as an individual, is to be negligent.
2. I understand that boating, club activities and related activities involve certain inherent risks, and I assume personally the liability for any injuries I might sustain during such activities. This waiver does not prevent me from making a claim against an individual whose negligence is believed to be the cause of injury.
3. I understand that every club activity, including boating ventures, is strictly social in nature and I understand that a minimal payment intended to off-set costs in no manner makes this a business venture.
4. I have read this agreement word for word, and I am fully informed of the effect and meaning.

### AGREEMENT TO MAINTAIN INSURANCE

If I am a boat owner, I will maintain liability Insurance on my boat (and also automobiles with which I tow my boat) providing coverage in the amount of \$300,000 Combined Single Limit.
