Terms of Adoption

The following agreement specifies what we feel is required to provide a safe and loving home for a cat. Please understand that the details of the contract reflect our concern that both owner and cat have a happy life together. The conditions set forth are based on years of experience and a continuing commitment to see that our rescue animals find safe and happy permanent homes. We hope that you will understand that considerable emotional involvement, time and energy go into insuring that our rescue animals have the best possible second chance at life.

If I am successful in the adoption of an animal from Wolf Point Pound Puppies, I herein promise and agree to the following conditions:

1. To contribute an adoption donation in the amount of \$25 if unaltered, \$50 if altered. Donation is fully refundable if cat is returned to Wolf Point Pound Puppies or their designated representative within 30 days for any reason.
2. To keep this animal in my personal possession, provide proper and sufficient food, water, shelter, grooming and humane treatment at all times.
3. I understand that this animal may not have been spayed or neutered at the time of adoption.
4. To procure veterinary care at once if it becomes sick or injured and to keep all vaccinations current as recommended by my veterinarian.
5. To obey any and all animal control regulations governing the area in which I live, and to license this animal according to such regulations within one month of adoption.
6. Not to sell, trade, transfer ownership, abandon, or dispose of this animal in any way, but to notify Wolf Point Pound Puppies or their designated representative if I must relinquish custody of the animal. This includes release to family members.
7. To notify Wolf Point Pound Puppies or their designated representative immediately if this animal is lost, or stolen and to make every effort to locate him/her.
8. To allow Wolf Point Pound Puppies or their designated representative to examine the animal and its living conditions and to surrender it to said representative for return to the organization if the conditions are found unsatisfactory.
9. To assume full responsibility for this animal's actions, and for any damage done by this animal.
10. I agree never to allow him/her to be transported in the open bed of a pickup truck or similar vehicle.

RELEASE OF LIABILITY AND INDEMNIFICATION

I fully understand that Wolf Point Pound Puppies cannot and does not make any representations or warranties, either expressed or implied, concerning the temperament, health, habits or background of this pet and that future reactions to me, my family, my pets and other persons and animals are completely unpredictable. Therefore, and in consideration of receiving this animal, I hereby release Wolf Point Pound Puppies from all claims of injury or damage, which this animal may cause me or my property. And I further agree to hold harmless Wolf Point Pound Puppies from any and all claims of liability to other persons for injuries or damage caused them by this animal while it is in my care or custody. My selection of this animal has been based upon my own observation of the actions and temperament, and I have selected this animal solely upon my own judgment.
