  - 5.3.4.8. #33 Victor Rojas (CSUF) found academy instrumental and worth every dollar.
  - 5.3.4.9. #35 Albaro Martin (UCR) being a director for 2 years and he learned a lot from training. Take the opportunity when available.
  - 5.3.4.10. #23 Amel Khan (CSUDH) learned things she can do differently at her institution. Learned HR protocols and procedures.

- 5.4.6. #10 Dalia Hernandez (CSUSB) recommends to include copy of invoice with check so we know what payment is for.
- 5.4.7. #25 Eva Amezola at a community college we don't control certain things.

### 5.5. COE Fair Chair Campaign- Laura Orozco (Study Smart Tutors)

- 5.5.1.Two ways to help:
  - 5.5.1.1. 1.) Pay institutional fee
  - 5.5.1.2. 2.) Pay own personal contributions
- 5.5.2. We did a wonderful job and surpassed our goal. WESTOP raised \$25,390 in personal contributions, raised \$421,740 total and reached 110% of our goal.
- 5.5.3. CEO raised \$225,625 in personal contributions and \$3.6 million total. Together, we reached 108% of our goal!
- 5.5.4. If institutional membership expired or you want to contribute, please contact Laura Orozco.
- 5.5.5. #36 Miriam Carrillo (Norco College) thanked Laura for taking over while on maternity leave. She emphasized how important it is to be an institutional member for COE. They are there to help and advocate for our programs. Every little bit helps.
- 5.5.6. #10 Dalia Hernandez (CSUSB) COE uses these funds to advocate for our programs. Make a one-time contribution or sign up for 10 for 10.
- 5.5.7. #79 Michele Scott (CSULB) Co-Chaired last COE conference. Commented that typically institutions don't have a problem until there's a problem. If you are not an institutional member then COE will not help. There's nothing COE can do for you so very important to be an institutional member. Figure out a way to contribute and it's a tax write-off.
- 5.5.8. #26 Maggie Regalado Rivera (PCC) their campus pays through indirect funds (recommendation for other institutions).
- 5.5.9. #15 Elizabeth Morales (Long Beach Community College) 10 for 10 is a great option too; give \$10 per month for 10 months and you won't feel it.

### 5.6. Legislation and Education - Horacio Aceves (Occidental College)

- 5.6.1. Amendment that was going to take away 2.5 million failed "Jason Lewis CTE". TRIO community must continue to advocate for \$60M increase for FY 2018. We are currently under a "CR" until December.
- 5.6.2. Many emails have been sent by Sam Blanco III, on TRIO listserv you can find list of programs funded.
- 5.6.3. Programs & Agencies expecting FY 17 funding increase, a second "GAN" was sent by the Dept of Ed.
- 5.6.4. Rumer that June 1st programs not getting 2.5 increase; should have received GAN with 2.5 increase.



- 5.6.5. Final slates for programs & agencies in "limbo" should be released by Sept 29th; there has been no news on applicants in the funding band
- 5.6.6. #17 Temo Solorio (Cal Lutheran) McNair just came out
- 5.6.7. COE is working with 35 EOC programs who were notified by Dept of Ed., they would be shutdown. At least 15 programs have been identified by COE as making sufficient progress. Need to continue to advocate so we don't lose these programs.
- 5.6.8. Program Officers shifting people around so this might be why you're not hearing back from them.
- 5.6.9. Make sure to thank your congress person; we need to celebrate the defeat of the "Jason Lewis CTE" amendment.

- 5.6.11. First-Generation Initiative Wednesday, November 8th
- 5.6.12. #79 Michele Scott (CSLB) notice to all new grants: make sure you meet your numbers.
