  - Late last week we were notified that a level 3 sex offender has moved into Narrowsburg at 4619 State Route 97.
  - Please review our FB page and the NYS Sex Offender Registry website for proper information as to alerting the community and the individual's right. You can search by county, town or zip code.
  - The individual is on parole under the watch of NYS and has a location/tracking anklet that is worn 24/7 while under parole.
  - Deputy Sheriff Patricia Costa will be monitoring the individual regularly.
    - Home verifications, random not scheduled
    - Day to day monitoring via satellite tracker by the state

Town Board has requested that the town clerk share the Sullivan county sheriffs post in regards to the community alert.
