Financial report

- Lorie-Ann Bartal reviewed the May Financials.
- Late Fees 4 homeowners owe at least 1 quarterly dues. Their fobs are deactivated.
- Board Resolution review tabled until the July meeting. The Board discussed creating a flat late fee instead of 18%. Nancy will send a revised draft of the Resolution to the Board.
- Recurring contractor/vendor Payments Nancy is now paying Penn Turf through their Intuit online payment system.

Maintenance Committee

- Pool
 - Passed All bacterial tests so far
 - Attendants doing a great job the time keeping app is working well.
 - Fob registration has gone smoothly
 - o There was an issue with the Chlorine pump. If It's Water talked Emily through the repair via FaceTime.
 - o Powerwash pool deck total cost was \$397.50
 - Guest fees were waived in June. There is a positive reaction from the residents. The pool is not overcrowded. Lorie-Ann motioned to waive fees for the rest of the season. Dan seconded the motion. All were in favor. Late fees will be waived for the rest of the season.
 - The pool is swim at your own risk. There is no diving. All pool rules should be followed while using the pool.
 - Amy Tyson earned her pesticide License for the pool certification and has volunteered to oversee the handling of chemicals at the Creekside pool. The Board wishes to thank Amy for her efforts and appreciates the savings it affords to the HOA.

Village Center

- Water Heater Inspection Update Lanco replacement Bradford 50 Gallon, gas, single vent with mixing valve. Cost was \$2,775. Reserve funds were used.
- Progress of Keystone Gun-krete/Penn Turf project This is complete total cost was \$2,398.56
- Water Fountain Lanco repaired Cost was \$203.62, but we are receiving a discount for the site visit.
- Fire Extinguishers were inspected Total cost was \$68.90
- A new first Aid kit was purchased Total cost was \$50
- Verizon bill A 2-year contract will lower the cost from \$38.71 to \$29.87 a month an annual savings of 108.48. Initially the purpose of collecting information was to cut expenses, however, the Board decided to table the discussion until pricing from Comcast that includes internet is obtained before locking into a 2-year commitment with Verizon.
- Deep clean of Village Center Total cost was \$150. The Board discussed having another cleaning done at the end of the season.
- Ehrlich pest Control Treatment performed total cost was \$140.98
- Drains off the pool deck are clogged. Dan arranged for a contractor evaluate cleaning the drains and provide an estimate.

- Courts Brenneman has been contacted several times and have been promised repair. Dan will contact them again.
- o There are ants in the loungers at the pool Dan will contact Ehrlich to treat.
- o Still working on finding affordable Umbrella and stands.
