

DO MUSLIMS REALLY WANT SHARIAH IN THE U.S.? CAN ISLAMIC LAW CO-EXIST WITH THE U.S. CONSTITUTION?

“Shariah, Shariah, Shariah. What’s the big deal? They just want to practice their religion freely like everyone else in America. What’s wrong with that?”

Does that pretty much represent your thoughts or those of your friends? Please, please tell us that it does not. However, if that does sound like something you might say, we have to tell you straight up that you are either totally ignorant about what is happening in the world around you or you are part of the movement that is hoping to eventually overturn the U.S. Constitution.

If you are truly ignorant about Shariah law and its devastating effects on every society it has ever entered in its nearly 1400 year history, then this website will help you to truly understand the problem if you approach it with an open mind. In addition, there are literally millions of websites and pages devoted to revealing the atrocities of Shariah law, so just start surfing. You’ll remember, from our previous lessons, that we are not interested in the religious aspects of Shariah, only the political – which most of Shariah is. Unfortunately, as we have discussed elsewhere, it is not possible to separate political Islam from religious Islam (*as per Islamic scholars*). Therefore, we are stuck with the whole package if we allow it to flourish here.

Let’s say that you have had enough exposure and education to realize that Shariah is very, very bad for everyone that is not a pious Muslim. But, you don’t believe that the fine, peaceful Muslims that have entered the U.S. want anything to do with it (*except for maybe a very small minority*). How can we analyze that?

First, let’s establish how many Muslims are in the U.S. According to a recent Pew Research Center estimate, there are approximately 2.6 million Muslims in America. And, as per the U.S. Census Bureau, the total U.S. population is about 315 million at the time of this writing. According to our calculations, that is less than 1% of the population. Of course, Muslim groups hell-bent on subversion will always claim it is much larger.

In the fall of 2012, an exclusive poll, conducted by the public opinion research and media consulting company Wenzel Strategies, randomly surveyed over 600 Muslims living in the U.S. Interestingly, over 97% of those Muslims were American citizens, who supposedly, are aware of America’s principals and are fully integrated into our democratic society.

Now, let’s take a look at the opinions and thoughts of these “enlightened” Muslims that have fled those evil Shariah law-ruled countries that promote torture and suppression of nearly all personal freedoms (*completely endorsed by the populations*). They say they have fully embraced their new host country’s cultural norms and mores and believe in (*and have sworn to uphold*) constitutional protections for all.

Now, let's open your eyes....

70% believe Christians do not have the legal right to invite Muslims to consider changing their religion (*or are not sure*). Extrapolation = 1,820,000 Muslims.

46% believe that any criticism of Islam should be a crime and punishable in a court of law. Extrapolating, that would be 1,196,000 Muslims.

39% believe that U.S. courts should defer (*consult*) to Shariah law when deciding cases. Extrapolating, that would translate to over 1,000,000 Muslims.

32% believe Israel does not have a legal right to exist or were unsure. Translation = 832,000 Muslims.

32% believe that Shariah should be the supreme law of the land. That would translate to 832,000 Muslims.

21% believe the U.S. needs to set up a separate and parallel legal system for Muslims only – Shariah courts. Translation = 546,000 Muslims.

21% believe (*or not sure*) that Americans should be put to death if they are found guilty of criticizing Islam or Mohammad. Translation = 546,000 Muslims.

20% believe U.S. law should be changed to allow for Muslim polygamy. Translation = 520,000 Muslims.

Wake up! The sad reality is that this info only reflects those that will openly admit to agreeing with those ideas! This isn't someone else telling you what they think or believe about American Muslims. This is directly from American Muslim hearts and minds. Hundreds and hundreds of thousands of American Muslims want America to be run just like the hell-holes they ran away from. This is the exact same way that all victims of abuse and mind-control cults act when given a choice for freedom. Truly, brain-washing is a powerful thing.

The individuals that participated in this survey are voters, folks. They are attorneys and doctors and engineers and government interns. And many of them are beginning to realize the path to the goal of Shariah America is to run for office.
